CHILDBIRTH TEA

There will be a tea on Dec. 10, 2:00 p.m., at 1024 Bonita Avenue for new and expectant mothers.

The tea, given by the Childbirth Education Association of Clark County, will be the first in a series of teas which will be sponsored by the association, each being on the first Thursday of every month.

Mrs. Lorraine Presco, certified Childbirth Education Teacher A.I.F.R. will speak at the tea on the "Importance of Preparation for childbirth". According to Mrs. Mary Truex, president of the Association, "There exist in our area a great need for education on childbirth and child rearing for parents as well as expectant parents".

The organization is a non-profit, non-sectarian, non-discriminatory association composed of men and women who are interested in promoting (prepared childbirth), family centered maternity care, not natural childbirth and parent-child relationships. The purpose of the Association is to serve in an educational capacity, not to dispense medical advice. In addition to the teas, the group also presents movies, lectures, and discussions on child development and the emotional, physical, and psychological aspects of parenthood.

TV 10 PLEDGE DAY

Sunday, December 6 will be Channel 10 Pledge Day, an effort by the public broadcast station to enlist financial support from the community to fund the evening non-commercial broadcasts.

The day's broadcast schedule, beginning at 2 p.m., offers "something for everybody," with programs for children; travel; Arthur Fiedler and the Boston Pops in a two-hour Gershwin concert; a rock concert with the Jefferson Airplane, Santana and the Greatful Dead; the popular Civilisation; and the first of a new series on The World We Live In.

The phone-in pledge format has been used successfully as a fund-raising project by other public broadcast stations, including Channel 13 in New York City, Channel 11 in Chicago, and Channel 13 in Dallas.

Public broadcasting (the evening broadcasts) on TV-10 are sustained entirely by contributions from local viewers, grants from local organizations and businesses, and other corporations.

Since Channel 10 first went on-the-air in March of 1968, its programming has been greatly expanded and improved. It is affiliated with the Public Broadcasting Service, National Educational Television, the Western Educational Network and Educational Television Program Service.
