

# JEW'S DENOUNCE JDL TACTICS

NEW YORK (WNS) --The bombing out of the Soviet cultural building of the Soviet Embassy in Washington last week has been deplored by Jewish leaders who denounced the act as "a foolish and wrong thing to do," and "a reprehensible act of terrorism that can only exacerbate the plight of Soviet Jews." It is not known who is responsible for the bombing.

A Jewish Defense League spokesman denied responsibility for the bombing but said "We do not condemn this act. The applause for it comes from imprisoned Soviet Jews." But the American Jewish Committee called upon President Nixon and the Congress to pass legislation "making a federal crime of the illegal actions against the official property and personnel of foreign governments in the United States."

NEW YORK (WNS) -- As the Manhattan District Attorney's Office announced it was presenting to a grand jury four criminal cases involving the Jewish Defense League, in an unrelated move New England JDL leaders announced their resignation from that organization.
