**SOVIET JEW ON TRIAL DENIES CONFESSION ALL CANDIDATES INVITED TO SUBMIT RESUMES**

TEL AVIV (WNS)-- In a telephone conversation with the newspaper Maariv, Mrs. Eva Butman denied that her husband, Hillel, one of the nine Jewish defendants in the second Leningrad trial, had confessed to anti-Soviet activities and had implicated his co-defendants. "All we did," she said, "was ask for a permit to go to Israel."

Mrs. Butman was refuting a report by Tass, the Soviet news agency, that Butman had confessed. In the report, for the first time, Tass said there were Israeli conspirators in the alleged plot to hijack a Soviet airliner last summer.

As protest against the new trial mounted Jewish emigres from the Soviet Union began a series of demonstrations throughout Israel and Foreign Minister Abba Eban told the

Knesset that efforts were being made to mobilize world opinion to secure the release of the imprisoned Jews.

(At the United Nations, Israel Ambassador Yosef Tekoah met with UN Secretary General U Thant to discuss the trial and urge the need for UN action. In the UN Economic and Social Council, Israel Ambassador Jacob Barmore called on the Soviet Union to release the imprisoned Jews and take "a more positive stand towards their national aspirations." Barmore also charged that Jews were being oppressed in Egypt, Syria, Iraq, and Libya and that in Syria they were being subjected to "Nazi restrictions" and threatened with extinction.)

(In the United States, there were demonstrations in Washington, Los Angeles and New York. The American

Zionist Federation assailed the trial as an attempt "to deter the Jews from requesting permission to emigrate to Israel" and from "identifying themselves as Jews." Twenty-five hundred people demonstrated in front of the Soviet Mission to the UN.
