

Soviet Israel Relations?

The Soviet's Peace Committee's invitation to a group of six non-communist Israelis for what the Committee said would be discussions on the Middle East situation with prominent Russians and for efforts to improve Soviet-Israeli relations could augur well for Israel. The fact that the Committee seems not to be official and that the Israelis are critics of their government's policy does not matter vitally.

What is important is that this seems to be the latest step on the part of the Soviets to establish some line of communications with the Israelis. And in the present international con-text, of political and financial fluctuations, this could be a healthy development. Were Israel able to re-establish normal diplomatic relations with the Soviet Union, it would widen her options In the uneasy truce with threatening Arabs. It would also free Israel from the burden of being overdependent on the goodwill of the United States government and some of those key-placed employes who are of two minds. Another potential and salutary benefit is that open intercourse could reach the Soviet Jews and not in the atmosphere of recriminations and tension which now exists.

NEW YORK -- The National Orthodox Synagogue body of American Jewry has issued a call for the Second World Conference of National Synagogue Organizations and Religious Councils which will take place in Jerusalem on January 9 - 12, 1972.

NEW YORK--A black cooperative movement in the U.S. South, convinced that the co-op system is a means of "bolstering the black self-image" and "stemming the exodus to overcrowded northern cities," has turned to Israel for training and technical aid, it was announced by the American Jewish Congress.

NEW YORK -- The American Jewish Committee called on President Nixon today to "convene concerned, national educational and religious leaders to consider together plans for possible implementation of 'dual enrollment' programs" as a means of meeting the financial problems of parochial schools.

CLEVELAND--Thirty-three young men and women between the ages of 18 and 25 have been granted scholarships by Hadassah to work, study and travel in Israel this year, Mrs. Morris Popkin, national chairman of Hadassah's Youth Activities Department, announced at the Annual National Convention.

CLEVELAND (WNS)--Delegates to the 67th annual national convention of Hadassah passed a resolution urging the United States government "to resist Soviet expansion in the Middle East" and "to grant Israel generous economic assistance to maintain her economy strained by the burden of defense." Another resolution called upon the U.S. and "the leaders of Christianity" to recognize Jerusalem as a "religious and national need in the life of the Jewish people" and "to support a united Jerusalem, which is, and must remain, the capital of Israel." other places, a Greenspun would be laughed at, his vileness would be overlooked and his humbug soon forgotten. But the consequences with which he is tampering right now in Nevada, jeopardizes the economy of the state and the very existence of all the residents. He must be stopped.

Again, we emphasize why it is imperative a fellow newspaper must take this stand. There is no other way. Like communists and crooks, who feel secure behind the Fifth Amendment, the Sun publisher exercises his repugnance in the safety of the First Amendment. Laws cannot stop him. The only way to wipe out this menace in our midst, this epidemic to our integrity, is to scourge him with the truth. The public will acknowledge reason, common sense and honesty in withdrawing its trust from this creature of destruction and all those he has contaminated.

We delve briefly into a glossary of the past nine months before going into details of Greenspun's BIG LIE, which he perpetrated last week.

Bob Maheu, general manager and spokesman for Howard Hughes Nevada properties (at \$10,000 per week) was fired abruptly by Hughes Tool Company directors, who naturally, refused to honor Maheu's unfinished commitments. Greenspun, who had already snared many millions of dollars by the sale of debt-ridden properties at exhorbitant prices to Hughes, via Maheu, did not take kindly to the loss of the goose that had been laying the golden eggs. Maheu sued for fifty million, and Greenspun commenced the undermining of the Hughes \$300,000,000 Nevada operations. Maheu lost the first round in District Court and the entire matter is now before the Nevada Supreme Court.

Greenspun blew up far out of proportion the most innocuous and removed items to discredit the Hughes operation. Front page after front page of the Sun glared over and over again with intimate details of far-fetched associations and personalities. False and unconfirmed rumors, planted in wire service stories and syndicated columns, were picked up and repeated on TV shows and in magazines, and then were presented back to Sun readers as authentic. Our story exposing the fraud was accepted by the District Court and became part of the official record.

Greenspun's attempt to discredit Intertel with a series of front page stories fell flat on its face when we revealed that among the directors of that reputable company were a former chief of Scotland Yard, a former head of Canadian Northwest Mounted, a former chairman of the board of Canada's largest bank and a former chief of F.B.I. Rackets Bureau, Hughes Nevada operations had engaged Intertel, a private company in the business of policing the operations of large corporations.

Contrast a story of a Hughes secretary involved in the sale of stock totaling \$150,000, which was blown up and front paged for days in the Sun, with a story of Hughes mining purchases at \$18,000,000, now not worth \$100,000, which occupied five paragraphs on an inside page. (See Jay Tell's version in this issue.) That's Greenspun's method of reporting news to Sun readers.

Now we come to the current Hughes applications for gambling licenses by Tool Co. directors, including Chester Davis, along with a proposed new set-up for operation of the seven gambling casinos. The State Gambling Board approved the applications. Just days prior to the final approval by the State Gambling Commission, Hank Greenspun showed his fangs. Now we go into detail.

(It should be noted we have never seen or spoken with Chester Davis, but from one who has spent many recent hours with him we are convinced he is a brilliant lawyer, who has earned a remarkable reputation and who deserves and gets total respect from all who know him.) Greenspun has singled Davis out for his current target.

On Aug. 17, an editorial appeared on Page (Continued on Page 5)
