With only four exceptions, elementary schools in the Clark County School District will start classes at 8:45 a.m., starting Tuesday, September 7, according to Theron Swainston, Assistant Superintendent for Elementary Education. Fay Herron in Las Vegas and elementary students in Virgin Valley will start classes at 8:30 a.m., and students at all grade levels except kindergarten will report at 8:00 a.m. in Indian Springs and Moapa Valley.
