Hitler Aide out of GOP

How many anti-Democratic individuals, including those with shadowy ties to the Nazis and Fascists of World War II and the Post-War period, are working in positions of power and influence in the United States?

That this is not an idle question is shown by the case of Dr. Joseph Paucó, a former aide to Joseph Tiso, Hitler's puppet ruler of occupied Slovakia, who was hanged as a war criminal after World War II.

Dr. Paucó had held the position of controller of the Heritage Groups Nationalities Council, an affiliate of the Republican Party's National Committee, until his record was exposed by nationally syndicated columnist Jack Anderson and his ouster demanded by the Anti-Defamation League of B'nai B'rith (ADL).

In his letter of resignation to Kansas Senator Robert Dole, chairman of the Republican National Committee, dated October 6, Dr. Paucó said he had been "cleared twice in similar circumstance." As a result he was admitted to the U.S. and enabled to become an American citizen.

If it is true that Dr. Paucó had been "cleared twice in similar circumstances," the question remains, if the charges against Dr. Paucó are true, that he was a Nazi collaborator in World War II, and an aide to Joseph Tiso, why was he "cleared twice?" And by whom?

And how many others with similar backgrounds, known and unknown to the general public, have been cleared by authorities and are serving in positions of power and trust?

The Paucó affair, the ADL stated, should serve as a warning to political parties of the need to close ranks against the intrusion of anti-democratic elements seeking to use them for their own purposes.

For America's social and political well being, it should take heed of the ADL's comment on the resignation of Dr. Paucó.

Piercing Prison Walls

A few days following the bloody Attica prison revolt, a released prisoner singled out "Jerry The Jew Rosenberg" as "the best guy the rebels got." Jerry was known as a jailhouse lawyer and apparently gave the rebels rather practical advice.

The counsel went to a prison population estimated to be 85% Black and Puerto Rican. And there is additional Jewish expression of concern about crime and the treatment of convicted persons that merits recall in this season of national stocktaking on penal practices. There is, for example, this statement issued in 1935 by the Central Conference of American Rabbis:

"The right of society to protect itself against those who constitute social menaces implies also the solemn obligation to do everything possible to remove the causes which tend to make men criminals and to make punishment corrective in spirit rather than retributive."

Many of the 400 prisons and 4000 jails in the United States are foul, shabby, unsanitary,

unsightly. A large number have been 50 years and more in service; some 100 years.

Some who read these observations now find Ramsey Clark, former U.S. Attorney General "too controversial" for acceptance. But they really should acknowledge his cautious appraisal that 95 cents in every one of the \$1,500,000,000 spent on corrections in this country go for prison walls and bars and guards while only 15 cents of each dollar are spent to answer the crying need for prisoner rehabilitation.

One authority has declared that American prisons continue to function as warehouses for long term storage of human refuse, an observation not far different from Oscar Wilde's first-person recollection:

"The vilest deeds like poison weeds
Bloom well in prison air;
It is only what is good in Man
That wastes and withers there."

Attica crowds in upon us with an irrefutable insistence that we match our fight against crime with a determination to reorder our prison system. Some 677 inmates at the correctional institution in Concord, Mass., proved a few days after Attica that prisoners know how to demonstrate without resorting to violence. One Concord inmate put the case succinctly: "We don't want to be excused for the crimes we've committed. But we want rehabilitation. It costs \$10,000 to keep a man here a year; yet only \$18 is spent on education."

The needed reforms were set down with great care by the President's Commission On Law Enforcement and the Administration of Justice, set up in 1965:

- 1- Establish with state and federal funds small-unit institutions in cities for community-oriented treatment.
- 2- Operate institutions with joint responsibility of staff and inmates for rehabilitation.
- 3- Upgrade the educational and vocational training for inmates.
- 4- Establish state programs to recruit and train instructors.
- 5- Improve prison industries through joint state programs and federal assistance.
- 6- Expand graduated release and furlough programs.
- 7- Integrate local jails and misdemeanor institutions with state corrections.
- 8- Provide separate detention facilities for juveniles.
- 9- House and handle persons awaiting trial separately from convicts.
- 10- Provide separate treatment to special offender groups through the pooling or sharing among jurisdictions.

Until we get on with such reforms, until we establish prison mechanisms for proper redress of grievances, until we act affirmatively on the full report of those now studying Attica, we had better be prepared for continuing prison crises.

Hughes and the management of the vast holdings in our state.

If it was just himself he is harming by his unwarranted blusterings, although we'd be sad to see a man ruin a reputation, it would be none of our business. But his vengeful, hateful, extremely dangerous accusations jeopardize the economic status of Nevada and the income of 8,000 working residents with families and homes and obligations. In addition, there is the item of a prominent Jew, whose questionable actions could reflect on the entire Jewish community.

You may ask at this point, Dave, "Why do you, Jack call on me? Why is my name brought into so controversial an issue?"

We answer: "Because there is no one else we know of, who Greenspun respects as much as you. Because he once bragged that a courageous District Court decision by you kept his career alive against powerful opponents. Because you and Hank are leaders of our Jewish community and you both are founders of our Temple Beth Shalom. Because you and Greenspun have been from the start, co-chairmen of the Israel Bond campaign. Because you once introduced Hank to an Israel Bond dinner audience as the greatest living American Jew. Because if you do not control him, bring him back to reason before the inevitable debacle, too many innocent persons will become victims. There is so much at stake."

Apparently the Mr. Hyde came out in Greenspun when Robert Maheu was removed as boss of Hughes Nevada properties last November. At the instant of the ousting of Maheu, the Sun publisher knew, of course, the many transactions that had taken place through Maheu, which netted Greenspun many millions of Hughes dollars. Many of the money transactions are not publicly known, even at this late date, and more are being uncovered. Sufficient to state at this time, that Greenspun has pocketed many more millions of Hughes money than has been reported, to date, in the newspapers.

Perhaps the sudden acquisition of so much money has gone to Hank's head. Perhaps he fears repercussions if the Tool Co. directors, designated by Hughes, should be licensed by the State Gambling Commission. Perhaps Greenspun's animosity springs from the loss of the opportunity to lay his hands on more of the Hughes fortune. Whatever it is, a malignity has developed in the publisher's mind, so warped, so filled with hatred, so violently hostile, he has lost all sense of proportion.

We are not going to repeat all the charges we have made in past columns, each proven beyond a question of a doubt. How Greenspun magnified tiny issues, making mountains out of molehills with false, misleading and inconsistent accusations. How he never once bothered to retract all those out-and-out lies. How he swung from personalities to generalities and back, defiling, damning, discrediting and defaming, without rhyme or reason. No, we are not going to rehash old proven truths, not today.

Instead we will dwell on Greenspun's most recent statements made during the past few days. Having exhausted most avenues of venom on the local scene, he is now slyly interjecting insolvency of the billionaire, and thereby attempting to spread panic throughout Nevada. When this tactic failed, he accused Hughes of renegging on a promise to donate \$300,000 to a University of Nevada Medical School. We had reported, weeks ago, the money would be forthcoming when certain provisions of the agreement were explained and determined to the satisfaction of Hughes Tool directors.

Then Greenspun turned to vulgarity which is the last rung on the ladder of reason. Here are his exact words with our comments, Greenspun:
