## JAY TELL'S OPEN LETTER TO HOWARD HUGHES

Dear Mr. Hughes:

For nearly two years the Las Vegas Free From and Las Vegas Israelite, both family owned, stood alone when headlining repeated

Secured loans are supposed to be filed with the County Recorder's office. This is to protect the lender from a borrower double-pledging the same collatoral. A typical example is a home mortgage or an auto loan. Maheu, it seems, "forgot" to file the loan papers!

This weird drama might have been surpressed forever, except it was accidentally discovered by the current Hughes executives while going through the few lifes Maheu didn't truck away the night be was fired last November.

Of course the loan was filed immediately upon discovery by Davis and Co. It's one more attempt to pick up the pieces and start

anew,

Mr. Hughes, you yourself have borrowed from the biggest banks in the nation. You have a life-long history of expanding and growing by successfully using borrowed funds and investing your assets on the future of America's growth. Your competence has paid off with a reported \$2 billion fortune which by all accounts is still growing. In light of his recent nauseating "Where I Stand' columns, so full of morivated, in-tentional lies, there is a strong probability that llank has finally flipped his lid. We almost Stand" feel sorry for the man. With his newly acquired Rolls Royces he can't even enjoy your millions. Recently he wined and dined the Henderson city fathers into selling him choice land at bargain basement prices, with your money.
