

**NAZI WAR TRIALS CONTINUE**

BONN (WNS) -- The longest and most expensive Nazi war crimes trial in history ended here with the release of three of the nine defendants on the grounds of health. The other six defendants received prison terms ranging from 18 months to seven years. They had been charged with murder and complicity of hundreds of Jews in Latvia during World War II. The trial lasted more than two years and cost more than \$1 million.

In Wiesbaden, the Federal Supreme Court reaffirmed sentence imposed by a lower court in Stuttgart on

two former SS battalion leaders found guilty of complicity in the murders of hundreds of Jews on the Eastern front during the war.

In another trial of former Nazis, charges were dropped against one of seven defendants being tried for complicity in the murders of 30,000 Jews in the Pinsk area of Poland. Alfred Ebener, 58, who

was deputy district Commissioner of Pinsk from 1941-42, was excused because of poor health, but the court refused to rule against a new trial for Ebener.

In Vienna, four former Nazis were arrested and expected to go on trial shortly. They were former SS Sturmbandfuhrer Ernst Lerch, deputy commander for death camps in Eastern Poland and his cohort deputy, Helmut Pohl; and two SS Sturmbandfuhrers Walter Dejaco and Fritz Ertl, charged with murder in the Auschwitz death camp.

NEW YORK (WNS)--Plans to create a National Community Security Council to protect threatened Jewish communities have been announced by Rabbi Wolfe Kelman, executive vice-president of the Rabbinical Assembly.
