Then Maheu came to the name of Chester Davis of New York, When that name was mentioned, the SUN has learned, "Hughes almost went through the telephone."

His exact expression was "God damn it, Bob, you must be losing your mind. If we allow this mad man to come to Las Vegas, in 24 hours the whole city will be devastated and in 48 hours the entire State of Nevada will be in chaos."
