NOW GET THIS: HE SAYS THAT INTERPRETATION IS FAR MORE IMPORTANT THAN NEWS. HOW DO YOU LIKE THAT? ACCORDING TO HIM THE SUN'S READERS DO NOT HAVE THE INTELLIGENCE TO UNDERSTAND THE NEWS, IT NEEDS HIS INTERPRETATION, WHICH, OF COURSE IS WARPED AND BIASED FOR HIS OWN SELFISH PURPOSE.
