Six months ago, a man and his family were transferred by their company to Las Vegas. In October, the man was discharged from his position and subsequently, in November, was admitted to a local hospital suffering from a severe bleeding ulcer, further complicated by a vascular condition which had previously been treated by his personal physician in Tucson, Arizona. Unfortunately, funds had run out for food and rent, and the family was certainly in no position to meet the emergency of returning to Tucson for life-saving treatment.

Hearing of the situation, Sam Keith, and William Weinberger, president of Caesars Palace, neither of whom had so much as met any of the stricken family, along with Catholic Welfare, arranged and paid for air transportation to Tucson for the ailing man, his wife, and son. Within twenty-four hours of their first knowledge of the emergency, they successfully returned the family to their home and the stricken man to the care of his physician.
