Greenspunism Goes On Sun publisher Hank Greenspun continues to ploy the most unscrupulous avenues of attack to discredit Howard Hughes, compounding every item that evolves to further his own nefarious

purpose. We have pointed out time and time again that Greenspun is no innocent bystander in the mysterious affairs of the bashful billionaire, especially in the operation of his Nevada properties. It has been shown conclusively, and without a finger of objection raised from any source, that the Sun publisher profited far more than anyone else after the advent of Hughes in Nevada. And we're not talking about legitimate transactions.

More than \$10,000,000 has passed from Hughes into Greenspun's pockets under the most questionable and suspicious circumstances. Debt-laden properties were sold far beyond their market values, a \$4,000,000 "loan" with no payments for eight years, a half million dollar cash advance for advertisements in the Sun, and assorted other taints of "finder's fees" and "kick-backs."

All of the money turnovers took place while Robert Maheu was chief of Nevada operations for Hughes. The moment Maheu was fired the money flow stopped. No public record was filed for the multi-million dollar loan or the advance payment on advertisements, and no mention of gratitude was ever made by Greenspun. In fact, the first revealing of these "deals" were unearthed recently by auditors checking the books after the ousting of Maheu. How much more was gleaned by Greenspun, only time will tell. Certainly, he won't.

We at the Israelite have made it perfectly clear, in no uncertain terms, that even an outand-out theft is not our main concern. That is a matter for law enforcement agencies, Some consider it a mark of valor to be able to steal from a man worth billions.

What we are concerned with, and very much so, is the effect being created on the economy of the State of Nevada by Greenspun's reckless, spurious and irresponsible accusations.

Let's not kid ourselves. The Sun publisher is a man of powerful influence in our state. Whether you believe or not, the actions of Gov. O'Callaghan on the Hughes matter is a direct reflection of the preaching of Greenspun. And why?
