6. The editor of Life Magazine was reported to be "crushed" when he heard the news that the \$650,000 was cashed.

When Mr. Hughes thought that a false autobiography of his life's events might reach the mass public, he became upset. This was enough reason for him to face the press, via telephone, and tell his side. When his voice was heard, one reporter said that was all the identification he would need. The Sun never. since the ouster of Robert Maheu, reported the facts about Howard Hughes and the Hughes Tool Company in an unbiased, journalistic way. Always the innuendos of negativism were injected. The other interesting possibility on this whole Clifford Irving mess is that it was instituted by some disgruntled ex-Hughes employee. According to Time Magazine, now a more than interested entity, reported that "Irving somehow obtained some or all of the material (for his book) in a computer printout."
