## DEMONSTRATE AT EL MONTE NAZIS

EL MONTE, CALIF. (WNS)--Some 40 demonstrators faced felony and misdemeanor charges after tossing bottles and rocks at headquarters of Storm Troop No. 5 of the National Socialist White People's (Nazi) Party following a march-by by 100 members of the Jewish Defense League. The JDL members had gathered in nearby Lambert Park, marched by the headquarters, returned to the park, and dispersed.

But some 1,000 residents of this suburban Los Angeles community who have been trying for four years to have the city force the Nazis out of the community, remained in front of the headquarters for an additional six hours before being dispersed by 100 police officers.

City officials say they can do nothing.
