After staying relatively close to the "pro-type" machine for the first half, in large part due to Booker Washington's superb shooting and floor generalship, the locals began finding themselves slipping out of the ballgame. A spirited rally with the help of 6300 screaming partisans brought the Rebs even with the Gamecocks with two minutes left in the contest. You all know the rest of the story; the visitors refused to get rattled even though playing 3,000 miles from home, playing in a gym they had never seen before, and playing in a game officiated by two referees who were not of their own choosing but were from the WCAC of all places. All of this seems to point out that they were the superior team and would have won the game anyway.

In the words of one visitor, "Everyone should be happy, the bettors (local) won, the team won a moral victory, our team won the game, and the school made money," All of this may be true, but did we win a moral victory in the eyes of our coaches? After all, the souther-ners lost to Houston by 10 points after they left town, partly because of the emotion-filled contest here no doubt.

The Rebs had several chances to win the game had they executed according to their skills, For instance, they shot only 13 of 22 free throw attempts. The visitors contacted with 28 of 37! They actually made 6 more than we attempted. This may not have been the best officiated game ever seen locally but the Rebs still could have pulled it out in spite of, not because of, the refereeing. In years past we had gained an unsavory reputation as a place not to bring a team if one was looking for a win, But now that the U. is playing in the major colleges, their refereeing has to be major league. We'd like to think the Rebs can win here without the officials help and last week's "moral victory" should have been the case in point. Amen



The Clark County Democratic Convention refused to adopt a resolution in support of Israel and Mideast peace.


