## Disgrace to Newspapermen

It is truly a shame that two journalistic jerks like Sun publisher Hank Greenspun and his columnist Paul Price should cast a cloud over the entire newspaper profession.

If either of the two were but casual writers intent on reporting the truth in the interest of justice, like practically every other newspaperman in the business, no matter how far off base they fly or no matter how illogical their dispositions, we could excuse their shortcomings as misunderstandings or misconceptions. But these two are not innocent bystanders. They are not honest, decent reporters writing for the edification of their reading public. Theirs is a nefarious purpose, deliberate and systematic, in this instance to discredit the courts and disrupt our whole system of jurisprudence.

In the case of Greenspun, he has already pocketed at least \$10,000,000 in cash from Howard Hughes under most suspicious and highly questionable circumstances. Price has been accused of extorting money from candidates seeking public office, a federal offense punishable by jail.

Greenspun is in jeopardy of losing his Sun newspaper property and Price could face a term in prison. Is it any wonder these two degenerate despoilers of a noble profession would go to any lengths to confuse and confound an innocent public with deliberate, malicious falsifications?


