

WHY WERE MATZOS DESTROYED ?

WASHINGTON (WNS) Rep. Robert N.C. Nix (D., Pa.), chairman of the House Subcommittee on Postal Facilities and Mail, announced that Postmaster General Elmer Klassen has been requested to testify at hearings to determine why the Postal Service ordered the destruction

of thousands of pounds of matzos which had been sent to the Soviet Embassy for Jews in the Soviet Union.

The Embassy had refused to accept the Matzos.

Sen. Harrison A. Williams Dr. (D., N.J.) has asked the Postal Service for an "immediate explanation" for the destruction of the matzos. He said they were apparently destroyed just hours after his office "contacted the Postal Service" in an "attempt to secure the matzos for distribution" to charitable institutions.

JEWISH DAY SCHOOLS GUIDELINES

NEW YORK (WNS) -- The Board of Directors of the Council of Jewish Federations and Welfare Funds have adopted guidelines for formal relationships between Federations and Jewish Day Schools.

Max M. Fisher, Council president, said the guidelines will enable the Federations to use their "know how to develop a financial strategy" to make the financially hard-pressed day school movement "generally viable." He said the guidelines "provide the first

pupil-hour basis; and a subsidiary of a portion of teachers' salaries on an interim basis as well as a step towards enhancing the level of instruction.

Federations have long been criticized by Day School sponsors, mostly Orthodox and Conservative, for what they called "inadequate" communal funds.

JERUSALEM (WNS) -- Dr. Nahum Goldman, here on a three-day visit to participate in a memorial meeting for the late Lord Sieff of Brimpton, urged that action be taken against the danger that Jewish immigration from the Soviet Union will be halted once the most vocal Jewish groups and individuals have emigrated from the Soviet Union.

WASHINGTON (WNS) -- Six members of the Congressional Black Caucus have asked Soviet Ambassador Anatoly F. Dobrynin in writing "for an end to the denial of exit visas to Soviet Jews who wish to emigrate to Israel or elsewhere."

BLACKS AGAIN CONDEMN ISRAEL

NEW YORK (WNS) -- The steering committee of the National Black Political Convention, meeting in Washington March 24, unanimously reaffirmed the condemnation of Israel approved by a voice vote in the closing minutes of the convention held in Gary, Ind. March 12.

The steering committee meeting was attended by Mayor Richard G. Hatcher of Gary, who had previously condemned the convention resolution, and by Rep. Charles C. Diggs Jr. (D., Mich), one of 13 members of the Black Political Caucus which on March 21 had issued a unanimous statement in defense of Israel's existence.

A spokesman for the committee said the committee had approved a "revised" and "softened" version of the convention resolution which had called for the dismemberment of Israel.

The "revised" resolution condemned Israel for the "forceful occupation" of Arab territory but eliminated the call for Israel's dismemberment.
