Testifying before the Federal Power Commission in Washington, D.C., Bernard Malamud associate professor of economics at the University of Nevada, Las Vegas, stated that a proposed 25 per cent

curtailment of natural gas to Southern Nevada would result in an economic loss to the area of \$18,660,000 in a recurring annual loss to the Las Vegas economy of \$9,198,000 in the event gas supplies were cut 25 percent.
