The Jewish Zuestion

During a news conference in Moscow on Soviet creative arts, the lack of Jewish newspapers was cited and answered by Alexander B. Cahakovsky, editor of the "Literary Gazette" with a reading from a 1935 novel written by two Soviet authors. A part from the absurdity of responding to a 1972 situation with material of 36 years ago, there are also some problems on our side of the question.

One has to take seriously the Soviet charges that acts of arson have taken place in a number of synagogues, that Jewish cemeteries have been vandalized as well as schools and centers. One has to be able to respond more sensibly to the Soviet assertion that Yiddish is known to less and less Americans. One has to say to the Soviets, that may be true, by the legal principle is established. Anybody can publish anything in Yiddish provided he has the funds, even if in Yiddish provided he he does not have the audience. Once we accept these criticisms at their face, not ideological, value then perhaps we can approach the Soviets as reasonably, and even say, but you do not permit it or perhaps you prevent and limit Yiddish publications. We must also be able to respond with more reason than rancor to Meir Kahane's claim that an American holocaust for Jews is in the making. If there is any truth to what he says, then it weakens the American Jewish position vis-a-vis the Soviets.

The action of an American correspondent in walking out of one of the meetings is not the way to meet the problem; it is avoiding it. Curiously enough, the most sensible statement was made by a Soviet Jewish Poet, Alexander Demshitz to whom it was recommended that there be a round table of talks between American and Soviet artists on the subject of Judaism. Demschitz said, "I know that we are prepared to discuss any question beneficial to human beings. I must add that we Jews don't have problems different from common problems facing the Soviet

people as a whole,'

If Demschitz meant there should be such rap sessions, we ought to take him at his word -Maybe even something good could come from it. At the very least it could be published in Yiddish.

Constitution are firm in their conclusion that the disestablishment tenet of the First Amendment makes illegal any use of tax money for religious education. And 25 years ago in Everson v. Board of Education, while ruling 5 to 4 that use of the taxpayers' money to provide bussing for parochial school children was constitutional, the Supreme Court made it clear that that wall of separation between church and state created by the First Amendment was applicable to the states through the 14th Amend-

In that historic ruling, the Supreme Court went further. It made this pronouncement, now constantly cited in Church-state rulings:

"The establishment of religion clause means at least this: Neither a state nor the federal Government can set up a church. Neither can pass laws which aid one religion, aid all religions, or prefer one religion over another. Neither can force nor influence a person to go or remain away from church against his will or force him to profess a belief or disbelief in any religion...

So how do Messrs. Nixon, Taft, Brydges, and other powerful political figures plan to kill, circumvent, or weaken this guarantee?

An astute politician, clearly aware of the fact that 95% of the nation's private schools are run by Catholic orders and Catholic dioceses, the President has publicly made avowal to Catholic leaders that he will not let the parochial schools down. The Nixon Panel on Non-Public Education, chaired by Dr. Clarence Walton, President of Catholic University, reported recently, calling for a sweeping private school aid program, including arrangements whereby a \$500,000,000 item would flow into the pockets of parents by means of federal income tax rebates. The President's Panel also wants to provide government loans for parochial school construction, special grants to urban private schools, and an equal-footing share for private schools in any new federal aid plan for public education.

Bishop William E. McManus of Chicago has said that he is fairly confident that the President will move in one or more of these directions by The date is significant. Such a September. maneuver coming only two months ahead of the election should help the President get many Catholic votes, a goal eagerly pursued ever since Mr. Nixon lost to John F. Kennedy. In addition, the courts could move in after the election and try to put together the broken constitutional pieces.

President on this issue. He has recently proposed a constitutional amendment permitting the federal government to grant income tax credit for part of the tuition paid by parents of parochial and other private schools. The New York Senate Leader --- Earl W. Brydges --- having decided to retire from politics, is pressing for constitutional change also. He wants the New York Assembly to call for a federal constitutional convention. But obviously aware that such a course is strewn with rocks, he is advocating state aid for parochial school building maintenance (for the sake of health, safety, and welfare) and also promoting tuition reimbursements for parents of private school pupils.

All these schemes, together with unending agitation for issuing vouchers to parents who send their children to private schools, will eventually get up to the Supreme Court. In the interim, federal judges in Ohio, New York and Pennsylvania have recently ruled against stratagems to skirt the First Amendment. But there is every indication that religious school enthusiasts, some of whom discount the importance of maintaining public schools, are going to drive even harder scoop up tax institutions.
