No News Good News?

At the summit meeting, a joint communique was issued on the Israeli-Arab conflict by the United States and the Soviet Union. It said, in part, that "the two sides set their positions on this question. They reaffirm their support for a peaceful settlement in the Middle East according to Security Council resolution 242," Both sides pledged their support of the Jarring mission and that they desired to contribute to its success.

More recently, Paris insiders quote Soviet Foreign Minister Gromyko as having said that President Nixon and Soviet Communist Party Secretary General Leonid Brezhnev discussed the Middle East in detail in Moscow but that "their disagreement on the evaluation of the situation was total," It was also reported that Gromyko, in Paris for meetings with French government chiefs, was "highly pessimistic" as a result of the near total disagreement.

And in Moscow on May 29th, Henry Kissinger national security affairs adviser to the President told newsmen, "This is a subject (Middle East) on which a great deal depends on the parties concerned and the power of outside parties is limited. Both sides favor progress.

That is like being against sin and in favor of motherhood. But with the developments lately even both questions are in serious doubt.

Let's examine the kindship of the two. O'Callaghan attends a governor's convention Dallas. The next day Lawrence O'Brian, the chairman of the National Democratic Party, invites Hank Greenspun, a registered Republican, to address the policy making platform committee of the Democrats. Why Greenspun, of all people? Where did O'Brian ever hear of the punk publisher, whose latest farce was to blast Nevada attorneys for not helping Greenspun save his own hide against forthcoming investigations by Federal agencies. The F.B.I. and the I.R.S. are hard at work to determine whether full and proper taxes were paid by those who glommed money from Howard Hughes.

Hank, in return, scratched Mike's back by suggesting the Clark County grand jury system be revised to the governor appointing the Blue Ribbon jurors. If you point a finger at Mike, Greenspun considers it a punch in his own jaw.

Now let us consider the latest diatribe instituted by Greenspun to protect the "good"

name of Mike O'Callaghan.

Judge Babcock's observation, very simply, was that the governor and the state have done nothing, and there is nothing planned to establish a minimum security facility for treatment of persons convicted and about to be sentenced, The only alternative a judge has, at this very moment, is to sentence the offender to prison or release the guilty party on probation. Nearly every judge agrees that prison is not the answer.

Let us analyze Greenspun's column on this

subject. Hank says:

IT APPEARS JUDGE BABCOCK JUST FOUND OUT THERE IS A NARCOTICS PROB-LEM IN THE COMMUNITY AND HE IMME-DIATELY STARTED BEATING UP ON THE GOVERNOR, THE LEGISLATORS AND EVERY-ONE ELSE WHO HAS BEEN WORKING PER-SEVERINGLY IN THE FIELD OF DRUG ABUSE.

This is not true. Judge Babcock just as 8-year-old, knows very well there is a narcotics problem. But there is no minimum security facility. The judge directed his criticism at the governor and the state legislature, not "everyone else," as distorted by Greenspun. The column went on:

IN FACT, GOV, MIKE O'CALLAGHAN HAS PROBABLY DONE MORE WORK IN THIS FIELD THAN ALL OUR OTHER GOVERNORS COMBINED, HE HAS BEEN WORKING ON IT SINCE THE DAYS HE WAS A PROBATION OF-FIDER IN CLARK COUNTY AND DEALT WITH IT AT FIRST HAND,

Here is a statement by Greenspun, that calls for specific information. We ask, just what has Gov. Mike O'Callaghan actually done, or proposed, or has in mind to establish a minimum security facility? We knew Mike O'Callaghan when he was teamed up with Moon Mullins (now a municipal judge) as probation officers tagging kids out after curfew. Mike was a grand guy in those days. He had compassion and feeling and applied every personal effort to aid and assist the youngsters. Those were the days Mike had to go through working newspapermen, like ourself, to get a story in the

Since then, he apparently has forgotten the very ones who supported him and elected him over favored Lt. Gov. Ed Fike. Mike refused to budge to help those taken unceremoneously off relief. It took federal Judge Roger Foley, who don't need support of any voters, to set the record straight and re-instate those who depended on the monthly checks for the absolute necessities of life.
