second "alleged" note, also was never filed. What the WSJ story does not reveal, but what we have shown on many occasions is that the second "alleged" note called for the first payment of principal, \$100,000 in the year 1980.

Now let us return to the WSJ story: NO MATTER WHICH LOAN AGREEMENT IS CURRENTLY IN FORCE, IT IS CLEAR THAT MR. GREENSPUN SECURED A VERY FAVOR-BLE LOAN FROM THE HUGHES OPERATIONS, A LOAN GENERAL MOTORS COULDN'T HAVE GOTTEN AT ANY BANK, WHILE MR, MAHEU WAS IN CONTROL OF THEM.

Mr. Maheu, of course, is Robert Maheu, the deposed chief of Hughes Nevada operations. Now our readers will realize why we were so insistent the transactions smacked of suspicion if not fraud. The same interpretation, as given by the WSJ, could be given to ALL of Greenspun's acquisitions of cash from Hughes through Maheu.

Now we come to the real reason we had to expose the corruption, and greed and disregard of responsibility by a newspaper publisher for his public. Here's how the WSJ put it: DURING THAT TIME MR. GREENSPUN WAS

ONE OF LAS VEGAS' GREATEST SUPPORTERS OF MR. MAHEU AND THE HUGHES OPERA-TIONS. BUT SINCE MR. MAHEU'S DISMISSAL MR. GREENSPUN HAS BEEN ONE OF THE CITY'S MOST VICIOUS OPPONENTS OF THE HUGHES NEVADA EMPIRE.

If the Las Vegas Sun had just been re-porting the news at the time, we would have reported the turn-about and then shrugged: "So what if billionaire Howard Hughes was clipped for a mere \$10,000,000. Hughes is a big boy. He must know what he is doing." What made us repeat, over and over again, what Greenspun was doing, was a newspaperman's contempt for the reading public. We had to expose this fraud in our profession, if we were to continue in it, with a clear conscience.

Here is another foul deed we brought to the attention of our readers. The WSJ story tells it all, exactly as we did on many occasions. IN ADDITION TO THE \$4 MILLION LOAN, HUGHES TOOL AND MR. GREENSPUN AGREED IN 1067 THAT THE COMPANY WOULD PAY

IN 1967 THAT THE COMPANY WOULD PAY THE SUN \$500,000 ON DEMAND FOR ADVER-TISING FOR THE HOTEL-CASINOS THAT WOULD RUN OVER THE NEXT 15 YEARS. HU-GHES-NEVADA DIDN'T EVEN GET A DIS-COUNT, APPARENTLY: THE ADS WERE TO RUN AT RATES PREVAILING WHEN THEY APPEARED IN THE PAPER. THE AGREEME-NT WAS NOT ANNOUNCED AT THE TIME IT WAS NEGOTIATED, AND HUGHES TOOL OF-FICIALS SAY THEY DIDN'T DISCOVER IT UN-TIL EARLIER THIS YEAR. FURTHERMORE, THEY SAY, THE SUN HAD BEEN BILLING THE HOTEL-CASINOS FOR ALL THE ADVER-TISING THAT IT WAS RUNNING, INSTEAD OF APPLYING THE BILLING AGAINST THE \$500, 000. IN AN INTERVIEW, MR. GREENSPUN ACKNOWLEDGES HE WASN'T APPLYING AD CHARGES AGAINST THE PREPAYMENT TILL EARLY THIS YEAR.

We could almost cry when we read the above in a paper like the WSJ. Here we are running a legitimate newspaper, the LAS VEGAS ISRAE-LITE, our advertisers constantly coerced by Greenspun, threatened by those seeking his favor, and we have to struggle to get out each week's edition. We have a constant, daily, battle with our bank account, and a punk pub-lisher, like Greenspun picks up a half-million in advance advertising WHICH HE DOES NOT HONOR FOR FOUR YEARS.

IN COURT PROCEEDINGS HERE, MR. GRE-ENSPUN TESTIFIED THAT HE REQUESTED THE LOAN FROM MR. HUGHES. MR. MAHEU FORWARDED A REQUEST FOR A MULTIMIL-LION-DOLLAR LOAN FOR MR. GREENSPUN "AT 6% OR LESS" IN A HAND-WRITTEN MEMO TO MR. HUGHES IN JULY OF 1967. BUT MR. MAHEU INSISTS THAT THE ACTUAL TERMS OF THE LOAN WERE NEGOTIATED AT THE INSISTENCE OF MR. HUGHES AND MR. GRE-ENSPUN SAYS IT WAS MR. HUGHES WHO WANTED THE LOAN KEPT SECRET. NEITHER MR. HUGHES NOR HUGHES TOOL OFFICIALS WILL COMMENT ON THIS ASSERTION.

What else can Maheu say at this time? Any other explanation would defeat his own legal action for \$50,000,000, claiming a lifetime contract of employment. IN ADDITION TO THE \$4 MILLION LOAN
