CARSON CITY -- Nevada has been assigned a major role in a nationwide effort to attract 25 million foreign visitors to the U.S. during the Bicentennial observance, Gov. Mike O'Callaghan said.

O'Callaghan received notification from Washington, D.C., that Nevada will be one of 10 states on the route of "The Selling of America," a cross-country mission Sept. 8-20 by the top international staff of the U.S. Travel Service (USTS) of the U.S. Department of Commerce, the national tourism office.

Headed by Acting Assistant Secretary of Commerce for Tourism the group will be in northern Nevada Sept. 10-11 for a meeting with O'Callaghan and activities in Reno, Sparks, Carson City, Lake Tahoe and Virginia City chosen to demonstrate the diversity of U.S. travel attractions for the foreign tourist.
