

TOM MULROY, WHO RETIRED AS CLARK CO-UNTY REGISTRAR AFTER SEVEN FRUITFUL YEARS, RECEIVED AN AWARD OF MERIT PLAGUE FROM COUNTY COMMISSION CHAIR-MAN JAMES BRENNAN ON BEHALF OF THE ENTIRE COMMISSION MULROY IS A CAN-DIDATE FOR STATE SENATE, DISTRICT 3.

Tom Mulroy, former Registrar of Voters, is a candidate for one of the four open State Senate seats in district number three,

A twenty-two year resident of Las Vegas, Mulroy headed the County Election Department during the period of June 1, 1965 until June 1, 1972 initiating much of the legislation that upgraded the conduct of all county elections. In the per-formance of his duties he received many commendations, among which were resolutions from the Nevada Supreme Court, the county administration, the 56th session of the Nevada Legislature and both political parties. Prior to assuming his duties in the re-

gistrar's office, Mulroy was southern area supervisor for the Nevada State Dairy Commission and from 1952 through 1959 was assistant superintendent of purchasing for Bonanza Air lines now Hughes Air West.

Mulroy is very well known and highly respected for his work in a number of fraternal and civic organizations. He is a member of the American Society of Public Administration; International Assn. of Clerks, Recorders, Elec-tion Officials and Treasurers; past state president, Nevada Fiscal Officers Assn.' past state president, Nevada Employees Assn.; past state deputy, Knights of Columbus; past commander, American Legion; treasurer, Friends of Youth and member of the Democratic Central Committee Executive Board.

His campaign statement is direct: "It's my intention as State Senator to devote all of my time in the public interest. Because I have

Don Hartwell Shaw, 46, of 4976 East Stanley has filed for the NEVADA Assembly District #20.

II. A. The Highway Department should place large signs on the highways at each state line stating: NEVADA DENIES BAIL TO EX-FEL-ONS.

B. As a defendant is getting out on bail, behind the property desk should be a sign, stating: IF YOU COMMIT A CRIME WHILE OUT ON BAIL WHEN ARRESTED AGAIN YOU WILL . BE DENIED BAIL; and he should be asked to sign a statement that he or she understands the sign.

III. WELFARE should be returned to the "Be-nevolent Organizations" on a competative bid basis for the cost of administration. The State Welfare Department should only be the auditors and abuse investagators.
