

# CANDIDATES INVITED TO SUBMIT RESUMES

## HARRY MANGRUM FOR ASSEMBLY

Harry Joe Mangrum, Jr. declared his candidacy for the Assembly District 10.

Advocating a reduction of taxes, consolidation of local government adoption of the "voucher plan" to restore parental control and authority over education and full time operation of the public schools, he is unalterably opposed to any state income tax.

He has pledged himself to work for an amendment of present grand jury statutes which allow county commissioners to hand pick their political cronies and proposes streamlining civil and criminal procedures to insure faster justice.

Long active in Republican circles, he was chairman of the Resolu-

tion Committee at the 1966 County Convention and campaigned for District Attorney against the former incumbent in 1970.

## JIM BANNER FOR ASSEMBLY

Jim Banner, Democrat and member of a pioneer Clark County family, is a candidate for the State Assembly from District 11 with a three-point program designed to improve benefits for public employees and the working man.

The public employees retirement system, the new collective bargaining law, and the workmen's compensation laws administered by the Nevada Industrial Commission are programs with which Banner is concerned.

Banner has been associated with governmental problems for the past 13 years and currently is the Personnel Officer of Clark County. He advocates equity in benefits paid by the public employees retirement system to retirees and emphasized the need for an office in Las Vegas to service employees in this area.

"We have several hundred members of the public employees retirement system employed in Clark County, yet there is no servicing unit in this area, and individuals must travel to Carson City, telephone, or correspond when desiring information. Also, there are inequities in benefits and I feel these should be corrected," he said.

Banner reported that the new collective bargaining law is inadequate and this should be strengthened to reduce much of the administrative delays currently required in arbitration.

Our workmen's compensation laws are archaic, he said, and there is a definite need to revise the workmen's compensation statutes. He pointed to the importance of upgrading standards of the NIC TO THE LEVEL OF THE Federal workmen's compensation coverage, along with changes in administration. A representative with Commission authority should be assigned to Southern Nevada on a full time basis to serve the majority of Nevada's residents who experience an industrial injury.

Banner has been a resident of District 11 for the past 24 years. He is a graduate of Las Vegas High School and received his bachelor of science degree from the University of Nevada at Las Vegas, majoring in Business Administration.

He has four children and his wife, Alice, is an elementary teacher in the Clark County School system. The 51-year old candidate was a business representative for the Carpenters' Local 1780 and later served as Commissioner representing Labor on the NIC during the administration of Governor Sawyer.

## Bilbray Takes a Stand

"Our national court system is badly in need of reform. Our courts are overloaded and cannot dispense justice fairly, efficiently, or swiftly

"I also support the Speedy Trials Act of 1971 and believe that we must provide greater availability for legal aid to insure access to justice to every American.

"Most political positions on the subject of crime in the streets deal with aiding our police force in the rehabilitation of criminals. You never see politicians taking stands in support of the people who are really hurt by crime... the victims. If elected to Congress, I would draw on the best economic minds available to study the feasibility of some type of compensation to victims of major crimes."

GUNCONTROL: "I do not favor federal gun control. I believe in automatic jail sentences for anyone who commits a crime either using a gun or while in possession of a gun."

POVERTY: "We need more jobs, not more welfare. Most surveys conclude that 80% of the people on welfare want to work."

"I also favor child day care centers for working mothers. Job retraining programs are badly needed for those workers who have lost jobs due to automation or industrial phase outs.

"Presently more than 70% of our welfare recipients are children, aged, or blind and disabled. I feel that we must increase our aid to the aged and infirmed, establish and maintain hot lunch programs in our schools, and food stamp programs for the deserving. I believe that the welfare system as presently conceived will bankrupt every state in our nation and that the system should be administered by the federal government, or revamped to give the states the money needed to handle their own programs. CIVIL RIGHTS: "I believe that if open housing equal employment opportunities, rent control, low cost housing, and equal educational laws already on the books were properly enforced, the ghettos of this country would disappear. Integration would then become a reality and racial strife would not be a social reality."

AMNESTY: "I do not believe in a blanket amnesty for those young men who fled the country or went to jail rather than serve in the Vietnam War. If their reason for draft evasion was a true moral commitment against the war, I feel they should be required to serve their normal obligations in non-combatative duty or in government agencies such as VISTA or the Peace Corps."
