Once Again Pawns

The stories out of Moscow that the Soviet Union is placing a price tag on Jewish emigration has an old-new ring and deserves the loudest international condemnation. However, it does lay to rest, as the New York Times has said editorially, Governor Rockefeller's claim to a Nixon-Breshnev agreement on Jewish emigration. Unless this is what he meant. The Times also said that Rockefeller's statement was followed quickly by the prices being raised.

Perhaps the only way to deal with this problem is practically. If it is money which the Soviet Union wants, and if the Jews want out, then the combination should be managed. The word ransom has a horrible sound; yet it has had a place in history. Even recently, President Kennedy ransomed the Cuban prisoners who fought in the Bay of Pigs and were captured by Castro's Army. Airlines will raise a half million dollars on hours notice to save a plane. And a plane is only a

Perhaps it is incumbent on the Jewish population of the U.S., the largest and the most affluent, to raise the money to bring those Soviet Jews out of that country who wish to leave. It is incumbent on the U.S. government to participate in such a program. Recently, it allocated a large sum to Israel for resettling immigrants. In this case, should some of the educated Soviet Jews come to this country, the money would be repaid in full by their contribution to the cultural, scientific and educational sectors of our national life. It would be a humanitarian gesture on the part of the government. However, it is the basic responsibility of the Jewish community to take the lead in this effort, should it come to pass.

And here is the Union of American Hebrew Congregations way back in 1909, daring to came out in support of the National Child Labor Committee and to join in that body's fight against child labor.

Not good enough?

Suppose then that we ask the National Council of Jewish Women to step forward and explain why it seemed important to that enlightened body to make a study of the intensifying crisis in day care in 77 cities, resulting in dissemination of a 264-page report advocating an expenditure by the federal government of \$2 billion in 1973 largely for pre-school and school-aged children of working mothers, the amount called for to be increased by \$2 billion annually for several years.

Why were nice Jewish girls spending their time delving into the needs of these millions of children when only an infinitesimal portion of

those needing day care are Jewish?

Because the need is desperate. Because the issue bears importance nearly equal to that of federal aid to education and medicare. Because. Because the number of mothers working today is twice that of 22 years ago. Because millions of the working mothers must bring income to the home or watch their children denied a decent place to live, warm clothing, and proper nutri-

And if these reasons still do not justify concern for the care of working mothers, expressed in the religious-ethnic press, perhaps a further consideration might be accepted: competent scholars (and we Jews do have a high regard for scholarship) have shown in countless studies that care or neglect, life in healthy surroundings or life in slums, balanced diets or inferior meals can determine habits and tendencies in later years. Children cared for offer far more promise of fruitful, constructive adult lives than those neglected.

Are not these Jewish concerns? And if moral compunction does not qualify as a factor justifying our anxiety about the care of children of working mothers, do not the physical factors and the economics and the potential of neglected children for lives of crime matter to us?

Day care centers may not be the perfect answer for the nagging problems presented by homes whence mothers set forth each day to win a part of the bread, needing care for their child-
