Harvest of Terror

While government leaders and persons of good will condemned the barbarism of Palestinian terrorists, the terrorists themselves identified as the Black September - intensified their nefarious deeds by introducing a new weapon of death; booby-trapped letters.

More than 40 such letters were mailed from Amsterdam and addressed to Israeli diplomats and leaders in more than a dozen cities in Europe North America, Africa and Israel. One of these sinister letters found its mark and killed an Israeli diplomat and injured another in the Israeli Embassy in London.

Postal authorities have characterized these bomb-laden letters as "cold blooded murder" weapons since they can kill anyone handling them. The explosive device resembles a strip of adhesive tape and the machanism releasing the lethal pellets is very much like a mouse-trap spring. When the letter is opened, or when any slight pressure is applied, the spring mechanism is released and the bomb set off.

The horror that engulfed the civilized world when Il Israeli athletes were slain in Munich was induced by the realization that the terrorists were carrying their murderous acts beyond the confines of the Middle East. The letter bombs make it even more obvious that the terrorists regard everyone, anywhere, as objects of murder. It is no longer a "Jewish problem." It is a world problem.

But speeches, resolutions, warnings and even meticulous security by postal and police authorities will not deter the madmen from wreaking havoc. Mindless acts of retaliation against Arabs will only tend to intensify terrorist acts and hurt innocent people who have not appointed the terrorists to act on their behalf.

A concerned and unified world effort must be undertaken to stop the terrorists before humanity is forced to reap the random harvest of the murderous deeds. Jewish and non-Jewish organizations should mount a three-pronged campaign demanding that their governments (1) apply economic sanctions, (2) sever postal ties, (3) freeze all assets of any country that harobors, aids or abets terrorists.

Heartsick Jesse Owens

Among the most poignant pictures out of the recent catastrophe at Munich was that of Jesse Owens weeping as only a heartsick human can weep, during the memorial service for the Israeli athletes, hostages to Arab terrorism.

Jesse Owens, the undisputed hero of the distasteful Berlin Olympics of 1936 and a man of fine

character then and since. must carry in his soul a true understanding of the sham and the shame of the Olympic games. The hypocrisy attending the spectacles, the brutal politics played out over them, the dark thread of racism and bigotry running through them are all drilled into the great Negro athlete who was snubbed by Hitler after the Owens triumph on the swastika-scarred playing fields of Munich 36 years ago.

Recorded faithfully in Mandell's recreation of the unending shame of those days are the parts played by Avery Brundage, active then and active now in top Olympic circles, and by General Charles H. Sherrill, a member of both the American and International Committees in the years that Hitler used the games to give his demoniac and brutal cause a polish of recognition.

Avery Brundage, in announcing, even before the Israeli martyrs' remains could be collected, that the Olympics would be continued, used only 27 words to express what grief he could muster the day after the Arab terrorists struck. He used many more words in October, 1936, when he spoke at German Day Exercises in Madison Square Garden, telling America why it had an obligation to take part in Hitler's spectacle and expounding on the theme that the U.S. had much to learn from Nazi Germany. Brundage's companion in fighting the honorable and wholesome movement to boycott the Nazi Olympics was General Sherrill.

Sherrill couldn't understand what the boycott call by Judge Jeremiah T. Mahoney was all about. After all, said Sherrill, the Jews had never produced a prominent Jewish athlete throughout history. (The prowess of David with slingshot must have escaped him.)

Later, addressing the Italian Chamber of Commerce of New York, General Sherrill praised Mussolini as "a man of courage in a world of pussyfooters" and continued: "I wish to God he'd come over here and have a chance to do that same thing."

Those who hold in their hands the reins of Olympicism had better think long and hard now about the Olmpic potential for promoting human understanding. Then they might go on to think who and what should really be barred from the sweet smell of Olympic grandeur. And beyond that they should join with the remaining forces of civilization in the inevitable determination to bar terrorists and nations harboring terrorists from the commerce and interplay of nations.

IF ROY WOOFTER HAS ONE SHRED OF EVIDENCE AGAINST ME, IF HE CAN PROVE THAT I CONCERTED IN ANY WAY WITH WES HOWERY IN SUCH A DEAL, HE HAS ONLY ONE RECOURSE.

HE SHOULD ARREST ME. I CHALLENGE HIM TO DO EXACTLY THAT. IN FACT, I DARE HIM TO DO IT.

There certainly is evidence against Price, not just a shred. To begin with, we have the sworn testimony of Woofter,

It is not sufficient, we all know, to charge a crime, but it certainly is evidence.

We will show additional evidence of a pattern engaged in by Price, with the knowledge and consent of Greenspun, of seeking and accepting monies for either favorable notices in his column or unfavorable ones kept out. But to get back to Greenspun's column:
