Sen. Edward M. Kennedy (D., Mass.), receiving an award at a Histadrut dinner held here, commended the Histadrut for sustaining and nourishing the character of Israel and inspiring leaders in every other land "by its proud example of progress, reform and social conscience."

He also warned that "We can leave no doubt in the mind of any Soviet leader, no doubt in the mind of any Arab leader, that our commitment is absolute to the survival and freedom and future of Israel and her people. There can be no greater goal of American foreign policy than the preservation of Israel."

3 ARAB KILLERS RELEASED

JERUSALEM (WNS) -- Following the release from German prisons of the three surviving Arab terrorists who participated in the Israel government expressed disapproval of the action. The three were released from jail and flown to Zagreb, Yugoslavia in exchange for 13 passengers and seven crew members of a Lufthansa 727 jet that was hijacked by Arab terrorists on a flight from Beirut to Ankara. The terrorist hijackers were believed to be members of the Black September movement, which was responsible for the Munich killings. Premier Golda Meir reported on these events at the weekly Cabinet

meeting. She said that Israel's Ambassador in Bonn was instructed to contact the West German government at the highest level to present Israel's appeal not to surrender to the hijackers' demands.

In New York, the Conference of Presidents of Major American Jewish Organizations and the American Zionist Federation expressed "shock and dismay" at the West German decision. Jacob Stein, Conference chairman, said the release would "contribute to the spread of terrorism" and warned that the German government "has assumed a great responsibility that may prove to be a very serious precedent."

"GUTS"

Keep Courts Clean

"We must keep our courts clean."

That statement was made by Alfred E. Smith in an unprecedented appearance of a Democrat before a New York State Republican nominating convention. It was not a request. It was a demand. The demand was granted, because Al Smith added, in a warning to the G.O.P. delegates: "If you do not join the Democrats in nominating Benjamin Cardozo to the state supreme court, don't look for any consideration from me in the next legislature."

Smith, at that time was speaker of the state assembly. He went on to serve four terms as governor. Cardozo was elected on a fusion ticket, rendered brilliant legal decisions and scored a monumental career as U.S. Supreme Court justice. The Columbia Encyclopedia Says: "Cardozo's approach to law was from the view of its effects on society rather than from hair-splitting logic."

Al Smith, "The Happy Warrior," who never got beyond the sixth grade to be nominated for President of the U.S., certainly spoke a mouthful, when he said: "We must keep our courts clean."

We are not an Al Smith. Justice of the Peace Robert Reid is not a Cardozo. Not yet. But if ever a courtroom is conducted with Cardozian
