#### JEWISH NEWS BRIEFS

AMSTERDAM (WNS) -- Justice Minister Andreis Van Agt has announced that the last three German war criminals held in Breda Prison will not be pardoned.

JERUSALEM (WNS) -- An ammendment to the criminal code which would make mandatory sentences for criminals using firearms, for criminals who operate in gangs, for protection racketeers and for suborners of witnesses, passed its first reading in the

BOSTON (WNS) -- Prof. Kenneth Joseph Arroe, 51, a Jewish economist at Harvard University, has been awarded the Nobel Prize for his "Impossibility Theorem," which argues that a "perfect form of government" is impossible.

NEW YORK (LNS) -- The Lubavitcher Rebbe Rabbi Menachem M. Schneerson, has called for the establishment of Jewish lending libraries in all Jewish communities, for all those interested in learning more about authentic Yiddishkeit and its observance.

NEW YORK -- Richard I, Fricke, Chairman of the Board of Mutual of New York, has been named General Chairman of the National Bible Week Luncheon scheduled for November 17, Hotel Pierre, New York City, it was announced by Myron L. Boardman, President of the Laymen's National Bible Committee,

NEW YORK -- The 58th Annual Meeting of the Joint Distribution Committee will be held on December 6, 1972 at the New York Hilton Hotel, it was announced by Edward Ginsberg, JDC Chairman.

WASHINGTON, D.C. -- Norman D. Tilles of Providence, Rhode Island, National Commander of the Jewish War Veterans of the U.S.A., will leave for England and Europe to make an emergency appeal to veterans groups in that area of the world for help in mobilizing world opinion against the Soviet Union's "appalling visa blackmail against Jews who wish to emigrate from that country.'

UNITED NATIONS (WNS) -- A statement deploring the fact that "more than 40 territories have not yet succeeded in gaining their independence" was made by Ambassador Ovadia Soffer at a ssession of the General Assembly on the granting of independence to colonial countries and peoples. In that statement, Israel pledged to support the "legitimate aspirations" of subject speople seeking to throw off the yoke of colonialism, "particularly the peoples of Africa, victims of persecution and racial discrimination like the Jews."

LONDON (WNS) -- Major security measures are being prepared for the British Liner Queen Elizabeth 2 to protect its 2000 passengers from possible Arab terrorism during a cruise to Israel next Easter,

TEL AVIV (WNS) -- Members of the Labor Party have criticized Itzhak Ben-Aharon, secretary general of the Histadrut for his recent call for a return to the ideals of the original Labor Party socialism.

PARIS (WNS) -- The libel suit brought by Leopold Trepper, the Soviet Union's master spy during World War II, against Jean Rochet, head of the French counter-espionage agency, opened here.

CHICAGO -- Israel's Ambassador to the UN Yosef Tekoah, told the American Zionist Federation convention that Israel "is at war Arab terrorism" and will take necessary action to "bring an end to this scourge."

JERUSALEM (WNS) -- The Interior Ministry announced that West Bank Arabs would be permitted to cross the Jordan River into Jordan iwith identity cars identity cards.

JERUSALEM (WNS) -- With relations between Israeli occupation authorities and Gaza Mayor Maj. Rashad Sahwa nearing a crisis situation, the Israeli Defense and Interior Ministries may hold new elections in Gaza.
