If elected:

3. Sanchez will emphatically oppose any attempt by other legislators to legalize abortion and will demand that this question, if considered at all, must be by referendum to the people of Nevada.

4. Sanchez will oppose any attempt by legislators to pass any secret or emergency laws which may deprive the people of Nevada, of their constitutional guarantees or which may impose on them undue burdens without their having an opportunity to voice their feelings and opinions.

5. Sanchez will insist on vote by referendum, of any issue which pertains to consolidation of governmental entities or of public services, noting that there will be attempts by promoters of this bill to deceive Clark County residents by claiming cost reductions in the operation of County Government, when the true intent and objective is for certain politicians to attain unlimited powers and control of local government thru one of the most shrewd power moves of this decade. It is unfortunate that already some moves in that direction have been taken and established without the say-so of the people of Clark County.

6. Sanchez will work for and support legislation which calls for measures to provide assistance to senior citizens and the physically handicapped. He will seek and fight for fair and equal treatment of public and governmental employees, with reference to their retirement fund and disability benefits also will

look into the Nevada Industrial Commission's problems with the idea of improving benefits and Workman's Compensation.

Sanchez, a 10-year Clark County government employee, in the Dept. of Building and Safety, is married to lovely Lanie, a native Las Vegas. He is a member of International Brotherhood of Electrical Workers, International Conference of Building Officials, International Association of Electrical Inspectors and Clark County Employees Assn.

Sanchez is active in Las Vegas #32 Masonic Lodge, Scottish Rite Bodies of Las Vegas, Kerak Temple of Reno, and Las Vegas Shrine in the Clown Unit.

He served from 1948 to 1953 with U.S.A.F. in Japan.

Sanchez, whose father is a Baptist Minister in California, is a firm believer in the Baptist Faith.

Sanchez, as a candidate for Sheriff two years ago, received more than 25,000 supporting votes from the residents of Clark County.
