Georg Rauch was born in 1924 in Salzburg, Austria into a family of architects, artists, physicians, and musicians. He studied painting and architecture at the University of Vienna, and in 1952 had his first one-man show in that city. Due to his numerous one-man shows and prizes he had the opportunity to travel and study in all parts of Europe, but especially in Greece, Italy, France, and Scandinavia. In 1966 Georg moved to Mexico and in 1970 decided to live and work in the U.S.

The works of Georg Rauch may be found in many public collections such as: The Albertina Graphic Museum, Vienna; Mozarteum, Guadalajara, and in the private collections of Elizabeth Taylor and Richard Burton Harry Belafonte plus many others.
