## FRENCH PACT


PARIS (WNS) ---France and Saudi Arabia have decided upon a policy of close political and economic cooperation, including joint con-sultations in international affairs, French arms sales and a multitude of public works to be undertaken by French companies.

King Faisal, who was due to leave May 18, spent five days here during which he held three political consultations with President Georges Pompidou, met with Premier Pierre Messmer and the Defense and Foreign Ministers.

Among the concrete decisions taken during Faisal's visit were the sale of French made Mirage jets, helicop-ters, missiles and tanks to the Saudi Arabian for ces which are reportedly beefing up their hardware as a result of the Saudi - Iranian crisis. Diplomatic observers here believe that France - Saudi the agreement will affect France's overall relations with the Arab world.

Pompidou had said earlier that France is not going to change its policies toward the Middle East, but that his government would continue its efforts to bring about a permanent peace settlement in the region which would have "to be based upon respect for the territorial integrity of the different states involved and upon resolutions adopted by the community of nations."

obvious. Just as obvious as his feeling for the public trust fund plan.


