

Greenspun's opinion on trust funds shifts

pun wrote lengthy editorials last month opposing the public trust fund plan by those attempting to build a monorail here.

This week in Henderson he pleaded with the Henderson City Council to finance 8,000 acres of his land exactly in the manner he was so critical of in regard to the monorail.

Off site improvements of the land owned by Greenspun will be financed under the Nevada Public Trust Law as a result of a "do pass" vote by a committee of Henderson City Council members. The official council meeting to vote on this matter will take place Monday.

Greenspun said in his April 20, 1973 front page editorial: "When the bonding capacity of the community is involved for private gain we have a horse of a different color." The land Greenspun owns, and hopes to finance by public bonds, is a proposed housing development.

Greenspun's editorial also said, "The Sunand many other businesses here - kept going through adversity and prosperity not with the backing of the public's tax dollars but from the keen spirit of private and competitive enterprise."

However, Greenspun apparently does not have this same feeling for the public's tax

Las Vegas Sun publisher Herman Greens- dollar where his own 8,000 acres are concerned.

> Greenspun's same editorial wisely pointed out, "One tends to be more cautious and prudent when using one's own money." Greenspun won't have to worry about using his money once the Henderson City Council gives him the final okay Monday.

The Council agreed to enter into a declaration of trust with the American-Nevada Prop-

erties Inc. at a special committee meeting Tuesday. The agreement means that bonds sold to finance off-site improvements on the proposed Green Valley Project will gain taxfree interest.

The trust monies will be used to construct "back-bone improvements such as water, sewer, streets, and flood control projects" in the Green Valley Project, according to Don Dawson, city manager.

Dawson said the credit of the city would not be endangered by the sale of the bonds.

Cruz Olague, city councilman and mayorelect, said the city was not obligated in any way and said the success or failure of the development wouldn't affect the credit of the city.

city wasn't completely committed to the ata7p.m. Monday meeting. project yet, adding he thought the public bru

law was a good way to get the needed improvements into the area.

Williams said the city was absolutely not responsible for pay-backs. The bonds are not city-bonds and aren't backed by tax money, according to Williams.

He said the Denver bonding company of Becher and Company would hold a first mortgage on the 8,000 acres owned by Greenspun

Williams called the public trust created by the Council action an aid to Henderson and said the tax money saved by not paying taxes on the interest on the bonds would lower the cost of homes in the final Green Valley Project.

Greenspun editorialized at the time of the monorail discussion that the Public Trust Law would involve the bonding capacity of the county. Greenspun said, in the monorail issue, that if the project failed, the bonds would become an obligation for the city and county.

Dawson said the benefits of the proceeds of the bonds, the off-site improvements, would revert to the city of Henderson after completion.

The Council action to enter into the bonding Lorin Williams, city councilman, said the agreement must be ratified by official action
