Judge Mullen came here in 1953, a Korean War combat veteran. Then 23 years old, he joined the Las Vegas Police force and later served as a depuy Sheriff. He devoted his off-duty time to youth work and study.

In 1961, Judge Mullen entered youth work full time, as a probation officer. In 1963, he became Judge David Zenoff's right arm as Chief Probation Officer and Director of Court Services. In 1969, he was elected Municipal Judge.

Nevaria Supreme Court decision against the City of North Las Vegas on the closure of an adult bookstore was a result "of the failure of Carl Lovell to even file a brief in the case," Las Vegas City Attorney Earl Gripentrog char-

The Supreme Court ruled against North Las Vegas saying that Lovell's appeal was "without merit". Gripentrog said Lovell's failure to file a Brief with the high Court "amounts to misfeasance in office in and all probability will cost the taxpayers of North Las Vegas hundreds of thousands of dollars."

After Lovell did not file a Brief in a case he appealed, the Supreme Court had no choice but to rule unanimously against the people of North Las Vegas', Gripentrog said. "The re-sult is that the book store in question can now be reopened. Further, an attorney representing the book store has indicated that he will seek damages against the City of North Las Vegas."

Gripentrog said Lovell's action was "legally indefensible and an affront to the people of North Las Vegas." Lovell is guilty of "political hypo-crisy." Gripentrog said, noting that Lovell Gripentrog said, noting that Lovell

continued, primarily in areas concerning youth, but also on behalf of the handicapped and afflicted. Still, although that work brought recognition to him from community leaders and civic groups, "Moon" Mullen's most significant achievement, the most important recognition, came from the citizens of Las Vegas themselves when they elected him the first black judge in Nevada's history.

His election indicated that a majority of Las Vegans were ready to judge a man's merits without reference to his race or creed. And nothing will go farther toward proving this, than Mullen's re-election by an overwhelming majority.

With his record of professional and civic achievement, Judge Mullen deserves re - election, and every person who values his own right to be treated fairly, not withstanding the circumstances of his birth, should and indeed must help to assure that this good and dedicated man is returned to office.

The Supreme Cour' action upheld the District Court decision of Judge Leonard Gang. In ruling against the City of North Las Vegas, the Court not only allowed the store to reopen, but required. the City to restock the seized material on the shelves, leaving the store in the same condition it was in before the closure.

A lawsuit naming Lovell and North Las Vegas has been filed by Attorney Henry Gordon, suing North Las Vegas for \$200,000.

Earl Gripentrog has filed 65 law suits with complaints and warrants against smut stores. but proceeded lawfully and legally. Consequently, Las Vegas has no lawsuits against it for improper seizure.
