

JEWISH NEWS BRIEFS

BRUSSELS (WNS) -- Dr. Jacques Zylberberg, a Belgian professor who was arrested by the military junta in Chile, has returned to Belgium after three weeks' imprisonment at the Kuirikuina naval base off the Chilean coast.

NEW YORK (WNS) -- The Anti-Defamation League of B'nai B'rith has reported that it received information that the military junta in Chile is friendly toward the Jewish community.

NEW YORK (WNS) -- The Israel government and the Jewish Agency office in Jerusalem have sent word here that "there is no need for blood donations for Israel at the present time," according to the National Committee on Control and Authorization of Campaigns of the Jewish Agency for Israel. "However, organizations and communities will register the names of those who wish to donate blood, and should it later become necessary, prospective donors will be contacted," the committee said.

JERUSALEM (WNS) -- Many leading Israeli "doves" who have often criticized the Israeli government for inflexibility were among a group of Hebrew University professors who issued a statement accusing the Arabs of seeking to annihilate Israel and supporting the government's policy of not moving from the territories until peace.

NEW YORK --- Six hundred programs, divided into fifty-five series of lectures and courses and a number of special events, are scheduled for the nineteenth year of the Herzl Institute.

NEW YORK:---An urgent call to American Jewry to rally to the help of Israel in its present emergency was issued by the Moetzes Gedolei Hatorah (Council of Torah Sages) of Agudath Israel, a body consisting of the foremost Torah scholars in Orthodox Judaism.

NEW YORK---Paul Zuckerman, General Chairman of the United Jewish Appeal, appealed to the American Jewish communities in a nationwide telephone hookup to "stand firm with the people of Israel by demonstrating our support concentrating within the next few hours, not days."

NEW YORK:---The question of strengthening Jewish identity and commitment in a world of shifting lifestyles and changing population patterns will be a major issue to be taken up at the biennial Convention of the United Synagogue of America, November 11-15, at the Concord Hotel, Klamasha Lake, N.Y.

JERUSALEM, AJPA, ---MORALE AMONG ISRAELI TROOPS IS HIGH. I HAD THE PRIVILEGE OF BEING ONE OF THE FIRST CIVILIANS TO TALK TO SOME OF THE VALIANT YOUNG SOLDIERS WHO ARE WRITING ANOTHER GLORIOUS CHAPTER IN THE HISTORY OF ISRAEL.

TOGETHER WITH DUTCH JOURNALIST EVA KELLERMAN AND BRITISH JOURNALIST ALAN SMITH I DROVE TO THE BATTLE ZONES. WE TURNED BACK TO JERUSALEM SOME 12 KILOMETERS FROM THE SUEZ CANAL.

WE VISITED ARMY CAMPS, ARMY REFUELING STATIONS AND A MAJOR AREA OF OPERATIONS. ALL ALONG THE VAST STRETCHES OF DESERT LAND, STILL SCARRED WITH THE RELICS OF 1967, WE SAW MEN ON THEIR WAY TO WAR.... SOME HAD ALREADY SEEN ACTION. THEY WERE BLEARY-EYED AND UNSHAVEN, THEIR UNIFORMS STAINED AND ASKEW. WHEN WE ASKED HOW THE FIGHTING WAS PROGRESSING THE WEARY FACES STRETCHED INTO SMILES. THERE WAS NO NEED FOR WORDS.

"HOW DO YOU FEEL?" WE ASKED ONE SOLDIER AFTER ANOTHER. THE ANSWER WAS ALWAYS THE SAME. "FINE, I FEEL FINE."

NONE SEEMED TO HAVE ANY THOUGHT FOR HIS PERSONAL SAFETY, BUT EACH WAS CONCERNED ABOUT HIS FAMILY. EVA AND I WERE BESIEGED WITH REQUESTS TO CALL A WIFE, A MOTHER, A GIRL FRIEND, WITH MESSAGES OF LOVE AND REASSURANCES FROM AVI, SHLOMO, ZION, URI, DAVID.....

SOME OF THEM WERE TOUCHING. A BOY DUE TO HAVE BEEN MARRIED YESTERDAY, BUT SENT TO THE FRONT INSTEAD, TOLD HIS SWEETHEART THAT THE WEDDING WOULD TAKE PLACE AS SOON AS HE RETURNS HOME. ANOTHER MAN WHOSE WIFE WAS GIVING BIRTH, SENT WISHES FOR AN EASY LABOR. ANOTHER SENT HIS REGARDS TO HIS GIRL FRIEND AND ADDED SHYLY, "TELL HER I LOVE HER, AND THAT I KNOCKED OUT TWO TANKS."

THE ALACRITY WITH WHICH PHONES WERE ANSWERED ALL OVER THE COUNTRY AT SO LATE AN HOUR, SPOKE VOLUMES FOR THE FEELINGS OF THOSE WITH THEIR MENFOLK IN THE FORCES. IT WAS THE FOURTH DAY OF THE WAR, BUT FROM THE CHARGED EMOTIONS WHICH EMANATED FROM TELEPHONES, ONE WOULD HAVE THOUGHT THAT THE WAR HAD BEEN GOING ON FOR A YEAR AT LEAST.

WE SAW THE HUSBANDS AND SONS OF ISRAEL, SOME OF WHOM HAD FOUGHT IN THE HAGANA AS YOUNG BOYS IN 1948; WHO HAD BEEN CALLED TO FIGHT AGAIN IN 1956 AND YET AGAIN IN 1967; AND WHO WERE STILL IN 1973 UPHOLDING THE DIGNITY OF THE JEWISH STATE.

WE WERE CONSCIOUS AS WE DROVE BACK THROUGH THE BUMPY ROADS OF EVER-INCREASING HUMAN REINFORCEMENTS.

NO ONE CAN PREDICT HOW LONG THIS

WAR WILL GO ON. MILITARY SPOKESMEN HAVE BEEN UNANIMOUS IN DIFFERENTIATING BETWEEN THIS WAR AND THE PRECEDING THREE WARS IN WHICH ISRAEL FOUGHT FOR HER SURVIVAL. THROUGH ALL ARE OPTIMISTIC OF AN ULTIMATE VICTORY, NONE WILL VENTURE TO PIN DOWN AN ACTUAL TIME.

ALL ARE AGREED THAT IT IS A SERIOUS WAR FROM WHICH ISRAELI TROOPS WILL NOT EMERGE AS RAPIDLY AS THEY DID IN THE PAST.

ARMY SPOKESMAN HAVE REFRAINED FROM TALKING ABOUT ISRAELI CASUALTIES, EXCEPT TO ACKNOWLEDGE THAT THERE ARE CASUALTIES IN EVERY WAR.
