## SAXBY APOLOGY OR RESIGNATION DEMANDED FOR UNCALLED FOR ANTI-SEMITIC REMARKS

WASHINGTON (WNS) Attorney General Wm. Saxbe, in an attempt to clarify his statement that "Jewish intellectuals" were "very enamored of the Communist Party" during the McCarthy era, has issued a statement that he had "long felt there was a great deal of anti-Semitism in the Communist witch hunts of the late 1940s and the early 1950's. Much of it was directed at some highly visible Jewish intellectuals who were considered sym-pathetic to Russia." He added that "because of the Soviet posture toward the issues of importance to Jews, this is no longer the case today and I believe this change can best be seen by the totally different type of individual involved in the terrorist groups now operating."

Saxbe's remarks have drawn the criticism from Jewish leaders and Congressmen. Reps.. Robert Drinan (D.Mass) and Elizabeth Holtzman (D.NY) have demanded

that he repudiate his statement. Drinan, a Roman Catholic priest, declared that "nothing less than a complete repudiation will suffice.

Ms. Holtzman said Saxbe's remarks were grossly inaccurate" & brutally insensitive to the history of anti-Semitism throughout the world." In a telegram to Saxbe she declared: 'It is genuinely appalling to me that you, as the highest legal officer in this country, could easily adopt the concept of 'Jewish Communist', a catch phrase that has been a chief of anti-Semites since Nazi Germany,"

Howard M.Squadron, chairman of the American Jewish Committees Governong National Council urged President Nixon to remove Saxbe if he does not resign first. Squadron accusing Saxbe of group libel said that Saxbe's original statement and his "clarification" that followed "demonstrate ethnic stereotype."

WASHINGTON (WNS) John P. Richardson, president of the American Near East Refugee Aid, long identified in pro - Arab activities here, told a House Foreign Affairs Subcommittee that oil companies

AVIV (WNS) -- The Labor Party is considering forming a new government in which the Cabinet would be reshuffled and Moshe Dayan would be moved from Defense Minister to some other post.

They want to stress the idea of ministerial responsibility for the mishandling of the Yom Kippur War. They say that senior army officers

Hank Aaron and Hank Greenspun performed exactly as we knew they would. The similarity ends right here.

Aaron hit his 715th home run, Greenspun took his 715th (just about) swipe at Howard Hughes, Aaron performed a legitimate achievement of breaking Babe Ruth's lifetime record. Greenspun is breaking the reputation of every legitimare newspaperman. Aaron will be graced in the baseball Hall of Fame, while Greenspun will be remembered as being disgrace to the profession of journalism.
The setting for Sun publisher Hank Green-

spun's latest outburst of frenzied antics is the Los Angeles federal courtroom where Robert deposed chief of Hughes Nevada operations is claiming 17.3 million in a slander action against his former boss. We are not concerned about the outcome of that suit because we know justice will prevail.

But we are concerned with Greenspun's pre-court comments of half truths, gross exaggerations and deliberate falsehoods. His purpose, with these fraudulent misrepresentations, is to discredit Hughes. His ultimate goal is to sway public opinion here in Las Vegas, when Greenspun's own suits come to court. Hughes is suing for the \$4,000,000 he loaned Greenspun, while the publisher is counter-claiming \$142,000,000.

On Feb. 15, Greenspun wrote in his "Where I Stand" column: A trial will be starting in Los Angeles Federal Court in the next few weeks where the forces of Howard Hughes will have an opportunity to prove all the bad things they have been saying about the former head of Hughes' Nevada Operations, Robert Maheu.

This, of course, was a completely false accusation by Greenspun. Hughes' forces have never circulated bad stories about Maheu. number of depositions have been taken, to be introduced at the trial, to prove the correctness of Hughes' statement that Maheu, "stole me blind,"

Greenspun stated: "And the biggest fish of all to be caught up in the dark and foreboding stories Hughes operatives have been spreading around, will be Hubert Humphrey, U. S. Senator, former vice-president of the United States and candidate for the presidency.

Readers will recall, Maheu swore he delivered \$50,000 to Humphrey, who, in rum

swore he never received the money.

Greenspun added: "The trial should disclose just how the money was handed over and the
