Palestinian Zuestion

As Israel prepares for the Geneva peace conference the Palestinian questions looms as probably the most difficult problem to settle in the negotiations with the Arab states. It is thus extremely important that Premier Yitzhak Rabin's government has reversed the attitude of its predecessors and has recognized that there is such a thing as a Palestinian entity.

It is fruitless to argue over whether there was such a thing as Palestinian Arab nationalism before 1948. The creation of Israel has given an impetus to this nationalism. But Palestinian nationalism, as different from general Arab nationalism was probably nurtured even more by the harsh treatment the Palestinians have received from the other Arab states. compare the situation on the West Bank and the Gaza Strip since 1967 where Arabs have been able to improve their economic conditions to that previously when Egypt and Jordan for political reasons kept the majority of Palestinians confined to refugee camps. Even those Palestinians able to get out of the camps have been discriminated against in every Arab country. So it should not be forgotten when Arab states talk about the rights of Palestinians that they have been the ones most guilty of denying them their rights.

There is a debate going on now in Israel on whether the Palestinian question should be settled through negotiating only with Jordan or with Palestinian groups who have recognized the right of Israel to exist as a Jewish State. While this debate is important in reality the form of representation for the Palestinians will develop as the next round of the Geneva con-

ference is organized. What is important is that Israel is beginning to deal with this problem in a realistic manner. The real question is now whether the Arabs are also interested in a realistic solution or just a propaganda debate.

Christian - Jewish Dialogue

A resolution urging the need for continued Christian-Jewish dialogue despite differences on public issues which was adopted by the National Jewish Community Relations Advisory Council at its recent plenary in Detroit deserves careful attention by the American Jewish com-

The NJCRAC noted that although the Catholic Church, for example, holds different opinions than most of the Jewish community on such issues as abortion and governmental aid to parochial schools, the public debate on these questions must be continued "with mutual res-pect and without acrimony." An engoing Christian-Jewish dialogue is important to the well-being of the Jewish community in the United States. There are too many causes for which Jews and Christians can work together to allow differences over some issues to cause an irreparable split.

Also present at the press conference were the Sun's Hyman, Price and Dodrill, who wrote the follow-up, in addition to reporters from other

A reporter asked Kaufman if he denied what Hyman had stated. Kaufman answered that he had qualified the statement to Hyman.

Whereupon Price blurted out from left field at Kaufman: "Do you deny you are under in-

Price was referring to items in his own columns, weeks previous, concerning Justice Zenoff, an honest and reputable jurist, who is known for fairness and decency. Price's story had provoked Zenoff into sending a letter to Kaufman, with a copy to Kaufman's opponent, stating he, Zenoff, could notethically or morally show partisanship in a district court race. The letter was marked PERSONAL AND CONFIDEN-

TIAL. At Kaufman's press conference we asked Price why he published portions of Zenoff's

Hyman and Price left the room.

Kaufman's secretary informed us she was present during the entire interview with Hyman. That's how close Greenspun looks at stories

that appear in his paper.

Before the session ended, witnessed by the assembled newsmen, we informed Judge Kauf-man that Price had told us he had permission from Justice Zenoff to print the confidential letter. Kaufman showed surprise and said he would call Zenoff.

The next evening, at the opening of Pat Ginn's campaign headquarters, both Jerry and Bunny Kaufman informed us that Justice Zenoff had vehemently denied giving permission to Price to print the letter.

Now to get back to Greenspun's column.
"The Sun," he stated, "does not want to be guilty of having people, for whatever purposes, use this newspaper for political exploitation. He continued with "---if there is any mud throwing in my newspaper, I would like to be involved with choosing the target and throwing the first glob." So spoke the granddaddy of all mud slingers, defending, not denouncing slimy practices, but reserving all privilege for himself. It figures.
