

ROY WOOFER FOR DIST. ATTY.

District Attorney Roy Woofler's record of accomplishments from 1971 to the present makes him determined to retain an office of continued integrity, administrative capability and increasing efficiency.

"Because of the ever mounting case load and a static budget, the problem takes on added responsibilities each month to perform with as near perfect individual and team effort as humanly possible," Woofler stated during a meeting with supporters.

According to his remarks outlining the history of his term as District Attorney to date, the progress was slow at first. After taking over the office in 1971, he pointed out, there

was an immediate restructuring to meet the needs of the expanding case load and to update all departments.

"Because of the continually rising demands to take care of all problems quickly and prosecute ably, the organization had to be flexible. Over the years to follow, the successful conviction counts just didn't happen by chance -- they were the result of thorough planning step by step. The expansion of services from the DA's office grew each year to the present where there are six more District Courts, additional Justice Courts in North Las Vegas and Henderson," Woofler said.

Pointing to the promises made in 1970, the District Attorney brought out the following facts: that he would work for full time Deputy DA's with enough compensation to make their prosecution jobs worth while and that he would eliminate all private practice for all attorneys in the office, himself included; would establish a 24-hour service with a Deputy DA assigned each week on rotation to cover the needs of any fast breaking cases; better communication with all law enforcement agencies by means of a regular bulletin; additional court servicing in adjacent cities; to become an active prosecutor by heading or trying as many cases as possible (Woofler tried seven important murder cases, won them all); to offer attorney services to County Commissioners instead of costly private lawyers for airport, hospital and other county entities; work on slot cheating preventive measures; call for citizen involvement in aiding law enforcement, plus expedite preventive measures

to stave off rape, muggings and other crimes; work with youth to form an effective District Attorney's Young Citizens Council with principal project "Laws for Youth" book; administrative efficiency and fiscal responsibility.

Woofler referred to his record in accomplishing all of the pledges he made during his first campaign and brought out future plans for the District Attorney's Office.

"I made an announcement in June of formation of the state's first full time, fully staffed consumer protection division in my office. Two years ago I brought forward a similar plan, but funding was out of the question then. Indications are that both country and federal aid can be sought and obtained at this time.

Pointing to the future, the District Attorney said he is working to introduce specialization into the office for higher efficiency. He is convinced this is the only way to solve increasing and complex cases, with Deputy DA's, investigators, administrators possessing special skills and knowledge operating within their particular frames. "It is also imperative that prosecutors have available to them, the best and most advanced techniques and methods for performing their duties. As president of Nevada District Attorney's Association, procedures have already been set up means for introducing processes for using a central data bank, a Witness & Victim Courtesy Accommodation Unit to aid in organizing time in this area and, finally, an Automatic Information Retrieval System with a criminal file in a standard data bank where any and all information may be gathered in minutes and updated on a daily basis. This is my promise for the next four years," Woofler concluded.
