A 19-year Las Vegas resident, Tony Badillo, has filed to run for the County Commission District "D" seat held by Myron Leavitt.

Badillo, 41 of 1067 Griffith Ave., is a dealer and has been employed in the gaming industry for 18 years.

The race is Badillo's first try for public office. He is a Democrat.

The father of seven children, Badillo is a veteran of the Army and a former restaurant and curio shop owner.

"I believe we need some new blood in politics," says Badillo. "I have no conflicts of interest, I am not self-employed. I do not have any business interests. I do not own my own business nor do I have any large property holdings."

Badillo says he is running for public office, "because I want answers and progress for our many needs."

Many sectors of his election

district are becoming "run down for lack of repair," he notes. "For safety reasons, I think stop signs and better lighting are needed at various locations.'

Badillo has pledged to aid sen-ior citizens and youth who he says are being ignored.

He sees a need for secure child care for working mothers.

"Our laws need to be enforced with courage and strength," Badillo adds as another thrust of his

MAHLON BROWN FOR JUSTICE OF PEACE

Las Vegas Justice of the Peace Mahlon Brown has filed for election to the judicial post he has held since his appointment earlier this year.

Brown, 35, pledged high bails for "narcotics profiters and those accused of wanton crimes of violence," and said he would continue his policy of greatly limiting attorney's fees for civil actions in justice court.

He also unveiled plans for changes in justice court "to allow the time needed to hear and prosecute properly all drunken driving cases.'

Brown proposed set-ting aside Friday mornings "to hear nothing but cases involving drunken driving charges. This is the most serious of all driving offenses. and we can best crack down by setting aside adequate time and space for the proper hearing cases."

He said such a procedure would do away with reasons for the lowering of drunken driving charges such as prosecutors or witnesses not being available due to overcrowded court condi-

court "must be increased in size, space and judicial staffing. He said one new judge and a traffic commissioner or another judge who would also hear traffic matters is needed now "to expedite the ever-growing caseload which is burdening the justice court.

"For example," Brown said, "there is presently only one day a week devoted to hearing small claims matters. This just doesn't allow sufficient time to hear those matters which are of such vital concern to the litigants.

Brown, son of State Senator and former Justice of the Peace B. Brown said the justice Mahlon Brown, was appointed justice of the peace in April by the Board of Clark County Commissioners to fill the vacancy created by the resignation of Rex Bell.
