

**MAYA MILLER FOR U.S. SENATE**

Political observers, who didn't give Maya Miller much of a chance when she announced her candidacy in February, are now saying she could win the Primary and would be very strong against any Republican candidate. For six (6) months, Maya has been talking and listening to Nevada voters in her person-to-person campaign to become Nevada's first woman U. S. Senator.

On a recent morning in Las Vegas, just after the sun had made its appearance over the eastern horizon, she was out hand-shaking and talking to workers coming off the graveyard shift at Strip hotels. Although the workers had just put in a long eight (8) hours, they paused long enough to ask Maya a few questions and listen to her answers.

"You know, the more I get out and talk with the people of Nevada, the more I'm convinced they are really eager for a major change in the way politics has been run in the past few years," she said. "Whether it's workers in Henderson, housewives in Las Vegas, ranchers in Elko, or businessmen in Reno, they all are saying essentially the same thing - 'let's clean up our government and make it work for us - not against us.' I don't think this is an unreasonable demand to make on our elected officials, especially in light of all the corruption at the national level we've been exposed to during the past few years."

"You know the people of this country have learned a great deal from the whole Watergate experience. It should be clear to everyone now that big-money, special interests are clearly detrimental to the consumer. After all, the milk fund contributions to the 1972 Nixon campaign have cost the American consumer about \$300 million in higher milk prices. And we're all paying higher prices every day at the supermarket because of the inability of the Nixon administration to adopt an economic policy that would hold back the 10 percent a year inflation that has unfortunately become a way of life. If Nixon had spent as much time on the needs of Americans as he did on rounding up money for his re-election and delaying the Watergate inquiry, we might have had a policy that showed more concern for working men and women and families, then the profits of conglomerates," Mrs. Miller said.

Even if she were in agreement with some of Nixon's policies, Mrs. Miller would still have

considerable cause to be upset by the Richard Nixon brand of politics, for she had the dubious honor of being put on the infamous Nixon Enemies List. Although it's unclear why she and her husband, Dick, were placed on the list, the idea of being the target for "special treatment" by governmental agencies in clearly inconsistent with Maya Miller's ideas about governmental authority.

"The whole idea of the enemies list has been taken rather lightly by some members of the press, but the implications of the practice as listing one's political enemies and then making that list available to certain governmental

agencies such as the Internal Revenue Service is disgusting -- and frightening," she said. "We should never allow such abuse of authority by any representative of American voters, whether it's a police chief, a governor, or the President himself," Mrs. Miller said.

Mrs. Miller was the first candidate to announce and file for the U. S. Senate. She is a 25-year resident of Nevada, and when not lobbying for worthwhile causes in Carson City and Washington, lives with her husband, Dick, in Washoe Valley, near Reno. Her 18-year old daughter, Kit, has taken time out from college to work in her mother's campaign, and 20-year old son Eric has joined the campaign in Reno.
