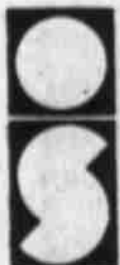

CATHY POST FIELD FOR JUSTICE OF PEACE

Cathy Post Field, one of four candidates for Justice of the Peace who came through the primary, says that she feels the results of the election prove two things: "Watergate had an affect and people are beginning to think twice before automatically voting lawyers into every office. It also was a woman's year in that not only did more of them run throughout Nevada, but a large percentage won. This certainly doesn't mean that we candidates who did are necessarily the only women who could have done it," Mrs. Field points out. "It merely means that we did file, we fought to win, and, hopefully it will encourage other women to enter politics as candidates and not confine themselves to campaigning for others."

Asked why she had entered politics, Mrs. Field told this story she read years ago. Little Mary, who hadn't spoken a word in all of her four years, finally blurted at breakfast: "Mommy, the toast is burnt." Her amazed mother shrieked with joy and said "Honey, why didn't you speak before this?" Replied Mary: "Well, up to now everything's been OK."

CHARLES THOMPSON FOR DIST. JUDGE

Clark County District Court candidate Charles Thompson became the first judicial candidate in Clark County history to release a full disclosure of his personal financial worth.

Thompson, who has campaigned on a platform of judicial modernization and equal justice before the law, said full financial disclosure "should be expected of every candidate for any public office."

"The people have a right to know if a candidate faces a possible plead cases thereby giving the poor people unable to afford a lawyer the short end of justice. Justice Courts were originally intended as equity courts where the people could go and stand equal before the law.

One day I mentioned this to a former J.P. He said: "Why don't you put your money where your mouth is and run. You have the qualifications." The next day, March 1, I became the first candidate in 1974 to file for Las Vegas J.P.," said Mrs. Field. "I realized complaining would accomplish nothing but campaigning might."

conflict of interest and all sources of his income," Thompson said. "Such disclosure is clearly in the public interest and can only contribute substantially to restoration of citizen faith in government at every level."

Thompson's financial statement for himself and his wife, Kathleen revealed total assets of \$52,625 and liabilities of \$6,306 for a net worth of \$46,319.

Among their assets, the Thompsons listed household furnishings, \$3,000; real estate \$16,388, two automobiles \$2,925; cash and a fixed term certificate of deposit, \$11,643; securities, \$900, and profit sharing plan, \$10,065.

Liabilities include a \$1,252 note payable to the University of Denver, where Thompson attended school.

Thompson is seeking election to Department I, Clark County District Court.
