UN Endangers Peace

While the adoption by the United Nations General Assembly of the resolution inviting the Palestine Liberation Organization to participate in the Assembly debate next month on the "Palestine Question" is a capitulation to Arab terrorism and oil blackmail, it was not wholly unexpected. But what was shocking was the lopsided 105-4 vote with such countries as France and Italy in favor and 20 others abstaining. Is any other evidence needed that the industrialized West is quaking before the Arab oil

Israeli Premier Yitzhak Rabin may not be too far wrong when he warned of a return to the "era of Munich" with the world this time "yielding to the power of Arab oil." Even the United States, which joined Israel, the Dominican Republic and Bolivia, in opposing the resolution seemed to be apologetic about her stand,

The United States and Israel did point out that the resolution endangers the efforts to achieve peace in the Mideast. The UN General Assembly has long shattered the hopes that it could be an effective force for bringing peace in the world. But its latest action may result in preventing peace from being realized in the

Nathaniel Samuel, an international banker and former Deputy Undersecretary of State for Economic Affairs, recently pointed out that Western industrial nations will put severe pressure on Israel to give back most if not all the administered territories, although he said they would draw the line at Israel's destruction. The General Assembly action is another example that the Arab states want to shove a one-sided solution down Israel's throat. Does anyone expect the Assembly's debate on the "Palestine Question" to result in a just solution to the Mideast conflict?

The Israelis have declared that they will not commit suicide. But is the rest of the world ready to become accomplices in the murder of the Jewish state? The invitation to the PLO murderers is a step toward complicity.

What an adventure my wife and I had in

That torrid Carribean island is moving up in its economic life and in tourism.

It's a beautiful island, with majestic scenery. American business enterprises are moving into the land, too. It's only three and a half hours from New York, and the tourist hotels are among the most luxurious on earth,

that's not why I went to Port au Prince.

I went to do a Bar Mitzbah.

There are only a few dozen Jewish families in Haiti. Some are Sephardic Jews. Some are refugees from Nazism. And some are American entrepreneurs who love sunshine.

One of the Haitian Jews is a cousin of mine, Otto Salzmann, who fled Vienna a step ahead of Hitler.

Otto's boy was turning 13 and he wanted him Bar Mitzvahed, but there is no synagogue, or religious school in Haiti.

So I sent young Richard the material he would have to learn to become Bar Mitzvah. An excellent tutor, Shlomo Cohen, once of Israel, trained Richard to recite his Hebrew.

And in July I flew down and in Mr. Salzmann's home, I Bar Mitzvahed Richard at a service attended by 150 people, Jews, Christians, Arabs, white and black.

A lovely reception took place.

Among those on hand was a very talented Israeli diplomat (or am I repeating myself?) the Hon. Zeev Bashan, the Ambassador from the Jewish republic.

In fact, I made history twice. For while I was there I also Bar Mitzvahed David Fleischmann. He is the son of German refugees, Mr. and Mrs. Leopold Fleishmann. event was graced not only by the entire Israeli delegation in Haiti, but by the secretary of the Israeli embassy in Santo Domingo, Eli Azulai.

Another pair of interested observers were the Rev. and Mrs. Carl Brown, Christian missionaries in Haiti.

Another interesting coincidence. Fleischmann, the father of one of the Bar Mr. Mitzvah boys, is employed by a business firm called House of Perfection, founded by Samuel Goldfarb, the renowned philanthropist, who lives now in Fort Lauderdale, Florida, a man I much admire.

It is truly a klaine veltele, a little world!

years and neither endorse one or condemn the other for the actions of Price. Nor do we intimate that Compton has any knowledge of Price being paid in his behalf. The readers can judge for themselves.

Price contends "I merely pointed out" (BY CONSTANT REPETITION - J.T.) "As a public service" (UH HUH - J.T.) "the facts." Let us see just how factual Price has been in

blasting Brennan.

Price claimed County Commissioner Brennan voted many times in favor of a company which was paying him a fee. Our investigation disclosed that the votes in question were not in favor of the alleged company but for persons doing business with the company seeking variance changes, etc. The company, an engineering consultant firm, had no interest in, took no part whatsoever in the business before the County Commission. Brennan never signed any register as Mr. and Mrs. and his traveling companions, the two other commissioners and their wives, who were constantly together with Brennan,

never saw another woman. Price demands to know why Brennan hasn't chosen to answer the charges. We know why

because we know Jim Brennan.

Jim Brennan, who has been practicing law locally since 1958, served as deputy district attorney, Southern Nevada Memorial Hospital trustee and Justice of the Peace, refuses to lend dignity to anything Price has to say. Jim is a casual man in daily life but rigorous in his professional capacity.

But Price has the answers now and it will be interesting to note whether he will check them out and make necessary retractions. We

doubt it.
