Municipal Judge Jerry Kaufman released his recommendations for "Rape Law Legislation."

Judge Kaufman stated that, "Approximately 50% of all rape victims never report their horrible experience. This is because they are embarassed or because their spouse rejects prosecution, or they are oftentimes ridiculed or harrassed on the witness stand. In a great many of the cases they are in fear of their future safety."

Judge Kaufman noted that defense attorneys interrogate the victim with regard to her previous sexual habits and experiences, and the victim is then put in the position of defending herself and her own reputation. Many states are now passing laws to surpass such evidence.

"If we are to make our streets safer for our women and children, we must pass laws and insure their endorcement to protect the defenseless woman who is attacked," said Kaufman.

JIM DEITCH FOR BD. OF REGENTS

Elaine Mills, long identified for her support of a growing University of Nevada, Las Vegas, has endorsed the candidacy of James Deitch for the university's Board of Regents.

Ms. Mills, who garnered 1,979 votes in the September 3 primary, and only narrowly lost a runoff spot in the November 5 general election, said she has confidence that Deitch "will carry out the goals and objectives I felt were important in the office of Regent."

"Rapists should not get off because a woman is afraid to testify because of ridicule on the stand. The terrible act of forcible rape is the issue and not the previous morality of the victim," stated Judge Kaufman.

"It is my position, in light of my opponent's record, that a judge should take an active part in the administration, adjudication and promulgation of the laws. It is a judge's duty and responsibility to see enacted such legislation regarding the use of evidence in their courts. The judge then becomes the conscience of the community and should insure the strict compliance with the law," concluded Kaufman.

"I feel that he will be approachable by those genuinely interested in UNLV and that he is willing to work with the community in regards to the university," Ms. Mills added.


