

DA'S OFFICE JOINS NATIONAL PROJECT

The Las Vegas District Attorney's office has been designated as an associated office in the National District Attorney's Economic Crime Project.

The adoption of the Las Vegas DA's office was made by Robert F. Leonard, chairman of the Economic Crime Project. Leonard, 41, is the nationally known Prosecuting Attorney of Genesee County, (Flint), Michigan, who has "created some of the nation's most effective and imaginative law enforcement programs," according to Newsweek magazine.

Leonard will make the formal designation in about two weeks when he meets with Clark County District Attorney Roy Woolter. Liaison between the central office of Economic Crime Project and the Las Vegas DA's office has been in effect for about one year.

The overall project targets economic crime problems which include not only consumer frauds, but also public corruption and organized crime and recognizes no state

MAHLON BROWN FOR JUSTICE OF PEACE

Incumbent Justice of the Peace Mahlon Brown was endorsed for election by the Nevada Narcotic Officers Association.

Brown was praised by the association for "excelling in your dedication and ability as a judge. You are respected throughout the state by law enforcement officers and witnesses who have testified in your courtroom."

The association said Brown is waging "a clean, professional campaign based on truths. We are encouraging our friends and associates to support you for re-election to Justice of the Peace."

"In your particular courtroom," the association said to Brown, "these roadblocks to the judicial process have not taken place."
