

**BILL YAKEY FOR SENATE 3**

William F. Yakey, Retired Air Force Major and 10 year resident of Las Vegas, is Republican candidate for State Senate, District 3.

Among his reasons for filing, are:

a. To obtain proper property tax exemption for Senior Citizens.

b. Revise NRS 361.260 method of assessment of property (residential only) to combat inflation by using cost of living index to stabilize valuation at pre-inflation values.

c. Screen the State budget very carefully to

d. Enact legislation to require Highway Patrol, Sheriff's Offices, and other police activities to conduct periodic vehicle checks for car safety.

e. Spell out the definition of a "cross-walk" and pedestrian right of way.

f. Set specific prison terms for convicted law offenses. Judges at present are way too lenient.

g. Classify degrees

of murder with mandatory death sentences.

h. Establish by law salaries for all Clark County and Las Vegas city elected officials.

i. Eliminate elective office of Mayor of Las Vegas.

j. All lobbyists must file and register with the Secretary of State.

k. Enact strict conflict of interest laws.

l. Barring any employee of a public government or entity or any agency thereof from filing for any elective office.

m. Enact into law some restrictions on mobile park owners to protect the occupants.

n. Present Metropolitan Police Force should be disbanded and revert to the former status of City Police and the Sheriff's Office.

o. I am opposed to any type of governmental consolidation as prepared by the Urban Action Committee.

p. I am not in favor of the "behind the scenes" push the Con-

vention Authority is giving to try and obtain 50% of the amusement tax from the general fund.
