

JEWISH NEWS BRIEFS

BONN (WNS) -- West Germany's "special relationship" with Israel has become obsolete and should be replaced by a relationship based on the democratic institutions the two countries hold in common, according to Martin Bangemann, the Free Democratic Party's secretary general.

WASHINGTON (WNS) -- The transfer by Iran of 24 American-built F-5 interceptor-fighters to the Jordanian Air Force had United States approval, according to State Department spokesman Robert Anderson.

MILWAUKEE (WNS) -- Three synagogues, the building housing the Jewish Board of Education and Hillel, and a delicatessen were defaced with-Nazi swastikas and slogans.

NEW YORK (WNS) -- A joint statement issued by 14 Christian religious organizations lauding the "positive" accomplishments of the United Nations General Assembly's 29th session was condemned by David Blumberg, president of B'nai B'rith.

JERUSALEM (WNS) -- Both Religious Affairs Minister Yitzhak Rafael and Ashkenazic Chief Rabbi Shlomo Goren have criticized the Vatican's new guidelines implementing the 1965 "Declaration on the Jews." Rafael blasted the document for failing to mention the existence of Israel.

TEL AVIV (WNS) -- Mapam has backed its political secretary Naphthali Feder in the political dispute that has arisen after it was revealed that Feder met with a Palestine Liberation Organization delegate during a gathering of multi-national peace committees in Prague last month.

NEW YORK (WNS) -- Some 300 persons participated in a demonstration outside the Soviet Mission to the United Nations protesting the death sentence imposed on Mikhail Leviev, a Moscow Jew accused of economic crimes and the abduction of 15-year-old Marina Tiemkin by the Soviet secret police to prevent her from joining her father in Israel, according to the Jewish Defense League.

TEL AVIV (WNS) -- Prof. Yuval Ne-eman, president of Tel Aviv University, has announced he is resigning to accept a senior position with the Ministry of Defense.

LOS ANGELES (WNS) -- A Jack Benny Memorial Forest will be established on the outskirts of Jerusalem "so that the name of one of America's greatest sons will be forever in Israel."

UNITED NATIONS (WUP) -- Stress is not simply nervous tension nor the result of damage. Above all, stress is not necessarily something to be avoided. Indeed, complete freedom from stress is death, according to Professor Hans Selye, Director of the Institute of Experimental Medicine and Surgery, University of Montreal.

NEW YORK (WNS) -- Sen. John Sparkman (D. Ala.), who has replaced Sen. J. William Fulbright as chairman of the Senate Foreign Relations Committee has said he favors a Palestinian state on the West Bank, but not one run by the Palestinian Liberation Organization.

TEL AVIV (WNS) -- Yosef Tekoah, Israel's Ambassador to the United Nations since 1968, has accepted the post of president of the Ben Gurion University of the Negev in Beersheba.

NEW YORK (WNS) -- The Artists Equity Association of New York has urged American member associations to withhold cooperation with UNESCO until UNESCO ends its anti-Israeli stand.
