Nevada chief Bob Maheu was ousted, the note was recorded. Because no payments had been made at the time (and none since), a token \$30,000 for interest was returned to Greenspun and foreclosure commenced against the Sun. Greenspun obtained a temporary injunction and counter-claimed for the \$142 million claiming a subsequent note extended the payments to the year 2004. Greenspun claims also he UNDER-STOOD the first note was not to be filed. Last year in the Maheu trial against Hughes, Greenspun testified he had "LOANED" Maheu

\$50,000 on the day he received the \$4 million. "It was never repaid," Greenspun swore under oath, "and I never even asked for it because Maheu was broke." Maheu was earning \$10,000

a week at the time.

It has never been made clear exactly what was the consideration for so large a sum of money passing from a man, whose every move made news, to a newspaper publisher. Nor was the consideration ever established for \$500,000 advanced earlier for future advertising in the It is interesting to note that Greenspun did not honor the advance, but accepted payment for the ads until the advance agreement was discovered four years later when Maheu was

Greenspun did not see fit at the time to reveal these large money transactions to his readers. They certainly were news, involving Howard Hughes. Nor did Greenspun reveal, obviously, were news, involving Howard the many other suspiciously clandestine arrangements which kept lining his pockets with Howard Hughes' money.

Yet in the hearing before the Supreme Court, Greenspun's lawyer stated, apparently with a LAS VEGAS ISRAELITE straight face, "Hughes has an obsession for secrecy

Greenspun admitted he had sinned and erred. but he never told his readers exactly what the sins were or the extent of the errors. Like the Watergate culprits Greenspun evidently is attempting to prove his innocence by justifying his guilt.

The phoney publisher, who claims he does not use his newspaper to further his own cause, only last week reprinted innuendos to discredit Hughes from dusty news clippings reported through the years. Greenspun topped them with "There are memos yet to be disclosed which will show the true measure of this man's (Howard Hughes) loyalty and patriotism to this country, and they may not be favorable."

To us, this appears to be journalistic black-mail. If Greenspun has such memos, why does he not print them now? Is Greenspun hoping his threats will cause Hughes to withdraw his suit

for the \$4 million?

We doubt if it will work, just as the same tactic failed during the Maheutrial, when Green-spun hinted of dire consequences to lawyers and politicians, whose testimony was yet to be heard. Nothing happened then, no heads rolled, and Greenspun's threats turned out to be whistling in the dark.

Don't you agree that the Sun's readers are entitled to the answers of many questions which are given to them piecemeal, under forced circumstances and usually when faced with perjury under oath. After all, Greenspun is a newspaper publisher and like all the others who are decent, honest and honorable members of the profession, there is a responsibility to readers. Forinstance:

What were Greenspun's sins and errors and what was the consideration for the millions he

received from Hughes?
Why did Greenspun "understand" the deed for the \$4 million transaction was not to be recorded, and how does the recording of the deed add up to \$142 million?

What was it that Hughes did not get, as bargained for, from Greenspun, as alleged by Hughes' attorney?

Why did Greenspun tell the "Tomorrow TV" show an attempt was made to break into his safe, even referring to scratches on the door, when he knew all along (and admitted recently) there was just TALK of a break-in, and never an attempt?

Why did Greenspun turn on Howard Hughes immediately after Bob Maheu was fired? Was he afraid of becoming possibly criminally in-volved, and certainly legally involved in dis-

closures that had been kept secret?

Why did Greenspun tell an interviewer most papers are run by absentee publishers, in it just to make a fortune, when he, himself, is an absentee publisher, who latched on to \$10,000,000 from Howard Hughes, enough to provide Rolls Royce and Penthouse?

Why did Greenspun tell an obscure publication he does not approve of gambling persay ----a parasitical type of industry, when he himself had an interest in the Desert Inn when

it opened?
What would your liberal friends say if they knew you told a swanky private club publica-tion: "I do believe the abuses such as welfare should be stopped?"

Now we'll ask a question. How come a President can be ousted, highest officers of the land found guilty, and some jailed, while one, single, isolated corrupt publisher remains immune?

Time will tell.

Greenspun flip-flop **Howard Hughes**

We ran into some folks the other day who had been reading Hank Greenspun and taking him seriously

This came as a shock to us until we found out that they were new in the area, and don't know the Las Vegas Sun publisher as we do.

After all, anyone who has lived here for any length of time knows that Hank is to be taken with a grain of salt may be even an entire salt shaker.

AS FOR US, we've always enjoyed Hank's antics - primarily because we know that what he says today and where he stands today is no indication of what he really thinks - or what he'll be doing or saving tomorrow.

The most recent example of the great contradiction that is Hank came a few days ago in an Associated Press story from Carson City.

It seems that Hank is suing Howard Hughes. Apparently Hank figures that he hasn't gotten enough money out of Hughes over the years, so he is taking him to court for \$142 million.

NOW, give or take a few million, Hank has sold his television station to Hughes for \$8 million, his Paradise County Club Golf Course and nearby land for \$2.25 million, and then borrowed an additional \$4 million from Hughes in a sweetheart loan that allows him to pay only three per cent interest.

On top of that, Hank also got a halfmillion dollar loan from Hughes to be paid off in advertising in his Las Vegas Sun. This loan is at no interest and no specified rate for the advertising.

BUT ALL THAT was hardly enough to satisfy Hank. He now claims he is entitled to \$142 million of Mr. Hughes' money on the basis that Hughes Summa Corporation clouded the title to some 2,000 acres of land that Hank-put up as security for the \$1 million loan.

What intrigued us in the AP story o the court case was the contention of Hank's lawyers that Hughes should be required to come into court and make a deposition "like any other person."

SO, NOW Hank wants Hughes treated like anybody else. That wasn't his position a few years ago when he was selling millions of dollars in property to Hughes or getting weetheart loans from the billionaire.

Hank didn't object before to Hughes getting special treatment. In fact, he urged it.

Hank never raised his voice once to say that Hughes should appear personally for his gaming licenses

HANK NEVER had a word to say against Governor O'Callaghan when he flew half-way around the world to meet with Hughes privately in London special treatment that other gaming licensees don't receive from the governor.

But times have changed, and now that it suits his purpose he wants Hughes treated like everyone else.

The AP quoted one of Hank's attorneys, Ralph Denton, as saying that Hank "has an obsession, that all men should be treated equal."

WE'RE CERTAINLY glad to know that. We've never really noticed it before. It escaped us completely when he was getting all those favors from Howard Hughes.

Anyway, we wouldn't want to take Mr. Denton's description of Hank any more seriously than we take Hank's own column.

What amazes us about the whole situation is not that Hank's position has changed over the years, it's that he's only suing Howard Hughes for \$142 million. We can only conclude that Hank is getting soft in his old age, or that he must have been in a benevolent mood the day he filed the suit.
