**DR. STERN'S APPEAL REJECTED IN RUSSIA**

NEW YORK (WNS) -- The Ukrainian Supreme Court has rejected an appeal by Dr. Mikhail Stern, the Vinnitsa doctor sentenced to eight years in prison on bribery charges, the National Conference for Soviet Jewry reported.

Dr. Stern's son, August, who is in the United States under NCSJ auspices, said: "My

father is innocent. He is being punished because of my brother's and my desire to emigrate to Israel. The Soviet government is trying to make an example of my father because he is a much beloved and respected physician. I appeal to all Americans to ask Soviet authorities to return my father."

Stanley H. Lowell, NCSJ chairman, said the organization would mobilize its resources on behalf of Dr. Stern.
