ALLON CRITICIZES US FOR ARMING ARABS

At 2:31 A.M. Wednesday, May 21, the 58th Session of the Nevada Legislature, the longest in the history of the state by nearly a month adjourned sine die.

In the waning hours a major measure which finally was agreed to by the two Houses make exemptions from the State Usury Law to try to solve the problem of money flowing from the state in time of nationally high interest rates like 1974. Whenever the prime rate of the nation's three largest banks reaches 9% the Nevada lending institutions are allowed to exceed that prime rate by 3.5%. However, the lender is not allowed to impose any charge or penalty for pre-payment of all or any part of the loan nor shall the lender require compensating balance or use of any other device to increase the costs to the borrower,

The operating budget was presented for a total general fund appropriation of \$369.5 million for the 1975-77 biennium. The money committees of the two Houses estimated that this would allow a reserve of \$22 million at the end of the period and the appropriation included \$2.5 million appropriated to the Interim Finance Committee to hopefully avoid any Special Session in case of fiscal emergency. Nearly 60% of the appropriation went to education including public schools and the university system with \$192,000 additional to handicapped children between three and five years of age. Although a resolution urging continuance of plans for a law school at the University of Nevada, Las Vegas was passed by both Houses, the money committees refused to fund it for the biennium.

The proposal to exempt food from the Nevada sales tax died as the Legislature adjourned in the Assembly Taxation Committee.

An obscenity measure which would allow control of X-rated bookstores and movies was passed by the Assembly but killed in the Senate Judiciary Committee.

A bill on Jam Auction control came so late in the Session that it wasn't even considered by the Senate.
