WASHINGTON (WNS) -- Israeli Premier Yitzhak Rabin completed two days of talks with President Ford and Secretary of State Henry A. Kissinger by declaring that unless there is a change in the Egyptian position from last March no interim agreement is possible between Egypt and Israel.

His remarks were made at a press conference only a few hours after Kissinger told reporters at the White House that a "parallel approach" by Egypt and Israel was a prerequisite for a resumption of his efforts for a second-stage agreement. Rabin said also that "parallelism" is needed. Kissinger said that further discussions are required with other Arab countries before the United States will determine its approach toward seeking further progress toward a Middle East settlement.

Earlier Kissinger had told the Senate Foreign Relations Committee that whether there is an American proposal in the Mideast depends on the evolution of diplomacy. He said if an interim agreement between Israel and Egypt is reached there will be less need for an American plan.

Ford greeted Rabin at the White House by reiterating "America's determination not to have

for Hank Greenspun*



LIAR'S LIPS, TAKER'S HANDS

Anytime Sun publisher Hank Greenspun tells a stack of lies which are reprinted in an apparent reputable magazine like Time, we refuse to stand silent.

When a falsehood is repeated over and over again, even the perpetrator begins to believe the untruth. The LAS VEGAS ISRAELITE assumes the responsibility of correcting the record.

The story in Time was obviously a publicity puff for Greenspun (which is all right) except that it was flagrant with bald-faced lies.

The biggest whopper of all was relating Hank's source of wealth. Time said: "Greenspun's substantial holdings -- the Sun, a cable TV franchise and local real estate -- have made him so rich..." This statement is so far from the truth it is laughable.

The one, the only and the sole source of Greenspun's millions, is the money he "took" from Howard Hughes. Before the billionaire came to town in 1967, the Sun was mortgaged to the hilt, the cable TV franchise wasn't in existence and to date has not returned one cent in income and the Greenspun name was on every listing of real estate tax deficiencies. During Hughes, it was a different story, amounting to more than \$10,000,000 in cash pocketed by the Sun publisher, who admitted he was working for Hughes at the time.

It started with finder's fees for the purchase by Hughes of the various hotel and casino properties. How much we'll never know until those who conspired with Greenspun come forward with the truth. At least \$25,000 came from a Washington attorney during the Desert Inn transaction. But these were mere peanuts.

Greenspun sold Hughes his TV station, KLAS, (Continued on Page 4)
