

**GOLDA MEIR SUES  
AJC MAGAZINE  
FOR 3 MILLION**

NEW YORK (WNS) Former Premier Golda Meir has filed a \$3 million libel suit in Manhattan Federal Court against Commentary, a magazine published by the American Jewish Committee.

She charged that an article in the magazine's Aug. 1974 edition was "false and malicious" when it claimed that she turned over a list of Soviet Jews to Stalin more than 25 years ago. In the article, "Notes on American Innocence," the author, Lev Navrozov, a Soviet Jewish emigre, alleged that while Mrs. Meir was Israel's Ambassador to the Soviet Union in 1948-1949 she gave Stalin, at his request, a list of Soviet Jews who wanted to fight for Israel in her war of independence. Navrozov said those on the list were arrested and sent to concentration camps where many died. He said his information was based on interviews with concentration camp survivors.

ants in the suit are Navrozov, the AJ Committee and Norman Podhoretz, editor of Commentary. In Israel, Mrs. Meir stressed that any money she received from the suit would be turned over to a fund for the settlement of Soviet Jews in Israel.

"The whole story is idiotic," Mrs. Meir told the Israeli newspaper Yediot Acharonot. She said she had

not wanted to get in to a dispute with the AJ Committee since "I do appreciate" the organization. She said she only agreed to file the suit when Commentary refused to apologize for Navrozov's allegation. She said she never had met Stalin and during that period the Israeli Embassy was prevented from having contact with Soviet Jews. "Did the police enable

**KNESSET MEMBER EXCOMMUNICATED**

JERUSALEM (WNS) The Knesset's annual debate on the Ministry of Religion has resulted in the Chief Rabbinate Council excommunicating Shlomo Lorincz, an Aguda MK for insulting Ashkenazic Chief Rabbi Shlomo Goren.

Lorincz, frequently a voice of the ultra-Orthodox in the Knesset, compared Rabbi Goren to Idi Amin of Uganda, saying both were paratrooper wings & both practiced tyranny, vengeance & dictatorship.

The Chief Rabbinate that Lorincz's public denunciation of Rabbi Goren "is an unprecedented scandal" and declared "The Council therefore relied on the Rambam (the 15th Century Jewish theologian and philosopher maimonides) saying that whoever humiliates the sages has no part in the olam haba (next world). If there were witnesses to the humiliation he must be
